2. Service & Support

4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Buyer Added Bid Specific ATC

Terms and conditions:

- 1) Service provider is required to pay salaries / wages of contracted staff deployed at buyer location first i.e. on their own which can be up to three months and then claim payment from buyer along with all statutory documents like PF, ESIC challan PT etc. as well as the bank statement of salary to staff along with salary slip. The service provider should not make any other deductions such as contribution to society, caution deposit etc other than the statutory deductions.

- 5) Bidder must ensure the submission of similar work order from any of the State / Central Government organizations.
- 6) Solvency certificate minimum 22 lakhs from bank (not above six month)
- 7) Should furnish valid ISO-9001 certificate for providing Manpower services
- 8) Should have minimum 3 years experience in providing Manpower services
- 9) Should submit minimum wages compliance certificate from the current client stating that the contractor is paying wages in accordance with minimum wages notified by the Chief Labour Commissioner Central to the employees engaged in various day-to-day activities.
- 10) Should submit proof of remittance of ESIC, PF, GST etc.

- 11) Should have registered under GST Act.
- 12) ITR for past 03 years along with balance sheet and profit & loss statement (FY. 2020-21, 2021-22 and 2022-23)
- 13) Current client list with contract details.
- 14) The service provider is required to have at least 50% of the required Manpower services provider payroll for at least one year. Necessary documents relating to such Manpower service will be uploaded by the bidder for verification of the buyer.

Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

11. Past Project Experience

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
