Hon'ble Minister of State (I/c) for Youth Affairs & Sports & Chairman, Governing Body, SAI, had desired that the composition of the Finance Committee may be reviewed and position existing before March 24, 2009 may be restored.

2.0 Before March 24, 2009, the Finance Committee Meetings were chaired by Hon'ble Union Minister for Youth Affairs & Sports. In February, 2009 the then Hon'ble Union Minister for Youth Affairs & Sports, also the Chairman of the Finance Committee desired that the Finance Committee should be headed by Secretary (Sports), Ministry of Youth Affairs & Sports (MYAS).

3.0 Accordingly, the proposal was placed before the Finance Committee in its 55<sup>th</sup> meeting held on 12<sup>th</sup> February, 2009. The Finance Committee recommended the proposal for the approval of the Governing Body. The same was placed before the Governing Body in its 36<sup>th</sup> Meeting held on 23<sup>rd</sup> February 2009 and the Governing Body ratified the decision taken by the Finance Committee.

4.0 As per the Memorandum of Association & Rules of Sports Authority of India, this change in the Chairman of the Finance Committee is to be brought out under Rule 34(b) which states that the Governing Body shall have the powers, subject to the provisions of these Rules & Bye-Laws framed there under to:

- (v) *"Appoint and dissolve committees and Sub-Committees consisting of persons who may or may not be members of the Governing Body or employees of the Society, for the purposes of the Society".*

5.0 Accordingly, Finance Committee was reconstituted with the approval of Chairman Governing Body, SAI, with the following composition :-

**DE-MERGER OF NETAJI SUBHAS NATIONAL INSTITUTE OF  
SPORTS, PATIALA AND CONSEQUENT AMENDMENT  
IN THE OBJECTS**

The Netaji Subhas National Institute of Sports (hereinafter "Institute") was set up in 1961 to produce the quality coaches so as to improve the standards of sports in the country. The Governing Body of the Institute viz.: the 'Society for the National Institute of Physical Education & Sports' was merged with the Sports Authority of India (SAI ) with effect from 1<sup>st</sup> May 1987. Since then the Institute is functioning as an Academic Wing of the Sports Authority of India.

2.0 The Government of India through the Ministry of Youth Affairs and Sports, vide its letter dated 4<sup>th</sup> November, 2011, has declared its intention to demerge the Institute from SAI. The purpose of such demerger is the development of the Institute as an institute for excellence for coaching education.

3.0 It is considered appropriate that the coaching education function of the SAI including the organization and running of various Sports Education courses and Coaching Education Programmes may henceforth be deleted from the functions and working of SAI and become the responsibility of a new Society to be registered for this purpose. The new society responsible for the Coaching Education will also function from the current premises of the Netaji Subhas National Institute of Sports at Patiala and will utilize the existing infrastructure of the Institute for its activities and it will continue to retain its current name in the form of "Netaji Subhash National Institute of Coaching Education". The existing facilities at the current premises of the NSNIS meant for training and coaching of top level athletes under various sports disciplines shall continue to be utilized by SAI for this purpose. After the registration of the new society and its coming into operation, SAI and the new Institute will enter into a mutually agreed arrangement under which facilities created by the Government at the Institute purely for the training and coaching of elite athletes would continue to be used for this purpose by SAI.

4.0 The Members of the Society have discussed the aforesaid and have agreed to pass the necessary resolutions to give effect to the above intention. Therefore, we being all/more than 3/5<sup>th</sup> majority of Members of the Society, hereby resolve as follows:

“RESOLVED that subject to the approval of the Central Government(Government of India) and confirmation as per the provisions of the Societies Registration Act, 1860 as applicable to the State of Delhi, clause 3 of the Memorandum of Association of the Society (**ANNEXURE-VI**) be altered by deletion of the following sub-clause (xi) and insertion of a new sub-clause after sub-clause (xxv) :

Regarding deletion of sub-clause (xi)

The following sub-clause (xi) shall be deleted:

- (xi) to provide for education, training and facilities for imparting advance coaching in various games and sports,
- (a) To carry on the management and administration of any Institute of Sports whether existing or to be set up and to admit students to course of training, to hold examination, to declare the result, to award Diploma and Certificates as and when necessary and to prescribe Rules and Regulations in connection therewith subject to Rules and Regulations of the University to which any such Institute may be affiliated;
- (b) To prescribe and conduct course of training institutions in Yoga and various games and sports and to demand such fees as may be prescribed by the Regulation, subject to Rules and Regulations of the University to which any such Institute may be affiliated;
- (c) To appoint all teaching staff and such other staff as may be needed for such Institute, on such terms and conditions as may be deemed fit and proper

Regarding addition of a new sub-clause after sub-clause (xxv)

“To undertake or to carry and carrying into effect any arrangement for demerger of any institution or body governed by the Society for the purposes of streamlining the operations of the Society for the optimum utilization of the resources.”

“FURTHER RESOLVED that subject to the final approval of the Government of India, the Society may demerge Netaji Subhas National Institute of Sports at Patiala from the Society, which is an institution currently under the Society.”

"IT IS FURTHER RESOLVED that this resolution may be forwarded to the Government of India in the Ministry of Youth Affairs and Sports for taking further necessary action in relation to registering the new Society and setting up the new Institute for Coaching Education."

**TARIFF CHARGES OF SAI STADIA AT DELHI**

The tariff for facilities available at stadia in Delhi have been approved way back in the year 1999-2000. All the 5 stadia complexes were competition venues for Commonwealth Games-2010 and after construction/renovation of these stadia, new facilities were also created in these stadia. Requests were being received from various stakeholders for providing these sporting facilities. Since the rates were more than 10 years old, a need was felt for revision of Tariff and for deciding the same for existing as well as new facilities presently available in SAI stadia in Delhi, the details of which are placed at **ANNEXURE-VII**.

2.0 Considering the urgency to provide the facilities to stakeholders, the revised tariff was approved by the Chairman, Governing Body of Sports Authority of India.

3.0 **Ex-post-facto approval of Governing Body is solicited for revision of tariff of various facilities in all five stadia in Delhi.**

2.0 Against the above projections, the Ministry has provided the following Budget Allocation for the financial year 2011-12:

3.0 In addition to above, there are closing balances of Rs. 1910.95 lakhs, Rs. 523.65 lakhs and Rs. 126.57 lakhs against Plan, Plan (NER) and internal receipts of SAI respectively. Further, grants-in-aid of Rs. 1601 lakhs sanctioned by MoYAS in 2010-11 have been received in 2011-12 (April 2011).

4.0 In the meantime, a meeting was held under the Chairpersonship of DG, SAI on 8<sup>th</sup> April 2011 to review the budget allocation vis-à-vis expenditure for 2010-11 and modalities for utilization of budget allocation for 2011-12 provided to Sports Authority of India (SAI). The following decisions were taken:

Rationalization of Booking of Plan and Non Plan Expenditure:

- (i) It was discussed in the meeting that activities relating to Sports Promotion and Development, Training, Maintenance of stadia /buildings and Academic Programme (Sports) are core activities of SAI and are related to development /fulfillment of activities assigned to SAI. Moreover, staff posted in various centres/units of SAI is also related to achievement of goals of SAI and are instrumental in the development activities of SAI.
  
- (ii) It was, therefore, decided to rationalize the booking of expenditure and only the following expenditure may be booked under Non Plan:
  - a) Salaries and Other Miscellaneous Expenses of SAI Head Office
  - b) Pension
  - c) Loans and advances

5.0 But from the allocation received under Plan against the requirements of SAI, it is observed that during 2011-12, it is not possible to book the expenditure on the salary etc. of staff posted in various centres/units under Plan. So, it is proposed that expenditure on salary etc. of various centres/units may continue to be booked under Non Plan.

6.0 All other remaining expenditure may be booked under Plan from current financial year 2011-12.

7.0 Accordingly, the following rationalization of heads of accounts is proposed:

**APPROVAL FOR CAPITAL/INFRASTRUCTURE PROJECTS TO  
BE MET OUT OF THE FUNDS AVAILABLE DURING THE  
CURRENT FINANCIAL YEAR 2011-12**

The following funds have been allocated in the annual plan for 2011-12 under Capital Projects/Construction works on the basis of budget allocation provided by MoYAS and funds available with SAI.

A.	Plan (other than North-Eastern States)	-	Rs. 2110.95 lakh
B.	Plan (for North-Eastern States)	-	Rs. 1241.65 lakh

2.0 A proposal for taking up funding of some on-going projects on a priority (since these projects were likely to be completed within March, 2012) was placed for consideration of the Finance Committee.

3.0 After considering the above, the Finance Committee in its 58<sup>th</sup> meeting held on August 10, 2011, resolved the following :-

(a) The following four on-going projects (for other than NER) have been concurred for the approval of Governing Body:

- (i) Providing & Laying of Synthetic Hockey field at STC Kandivalli - release of additional funds of Rs. 118.00 lakh (Revised Estimates 348.00 – 230.00 Original Estimates)

Agenda Item No. XII**OUTSOURCING OF CLEANING AND SCAVENGING WORK RELATED TO DR. SHYAMA PRASAD MUKHERJEE SWIMMING POOL COMPLEX (SPMSPC) AND MAJOR DHYAN CHAND NATIONAL STADIUM (MDCNS) THROUGH NEW DELHI MUNICIPAL COUNCIL (NDMC)**

Sports Authority of India is the custodian on behalf of Ministry of Youth Affairs & Sports (MoYAS) for nine sporting venues in five stadia, i.e., J N Stadium Complex (JNS), I G Stadium Complex (IGS), Major Dhyan Chand National Stadium (MDCNS), Dr. Karni Singh Shooting Ranges (KSSR) and Dr. Shyama Prasad Mukherjee Swimming Pool Complex (SPMSPC). There has been increase in the built-up area at the venues as compared to the past. It was decided in a meeting with MoYAS held on 21-12-2010 that SAI should requisition for extra man-power from MCD and NDMC, as and when required, on payment basis. An analysis on the available number of safaikaramcharis in SAI indicated that they would be insufficient for cleaning to desired standards. The matter was, therefore, taken up with NDMC for providing cleaning and scavenging services to Dr. SPMSPC and MDCNS as both the stadiums fall within the jurisdiction of NDMC. Accordingly, a committee was proposed to work out the scope of work at both the Stadia, which was sent to NDMC to work out a detailed proposal. Initially, the proposal was received for one year. But later, it was decided and recommended that the proposal would be obtained for six months extendable for another period of six months. A detailed proposal was received from the NDMC for six months which is as follows:

2.0 As per the delegation of financial powers, DG, SAI has the powers to sanction Rs. 1.00 crore in each case in regard to Maintenance work of existing infrastructure / building / Stadium/ Play fields provided execution work is entrusted to CPWD through deposit works.

3.0 The Finance Committee was requested to concur the following:

- (i) Ratification of Cleaning and Scavenging work related to Dr. SPMSPC and MDCNS through NDMC at an estimated cost of Rs. 2,11,86,082.00 for a period of six months, i.e., from 18<sup>th</sup> May, 2011 to 18<sup>th</sup> November, 2011 (as per para 1 above).
- (ii) Providing administrative and financial approval to NDMC to take up cleaning and scavenging work of Dr. SPMSPC and MDCNS through NDMC for 6 months after 19<sup>th</sup> November, 2011, after assessing the progress of work.

4.0 After considering the above by the Finance Committee in its 58<sup>th</sup> meeting held on August 10, 2011, the following resolution was taken:

**“The Finance Committee concurred for the approval of the Governing Body the Cleaning and scavenging work related to Dr. SPMSPC and MDCNS through NDMC at an estimated cost of Rs. 211,86,082/- for the period of six months i.e. from 18<sup>th</sup> May 2011 to 18<sup>th</sup> November, 2011.”**

4.1 Further, Finance Committee also agreed that SAI may continue the cleaning and scavenging work at Dr. SPMSPC and MDCNS through NDMC for a further period of six months from 19<sup>th</sup> November, 2011.

4.2 It was further directed that after a period of six months, i.e., after May, 2012, the other possibilities may also be explored.

**5.0 The proposal is now placed for approval of the Governing Body.**

The Civil, Electrical, Horticulture and Watch & Ward of SAI Stadia (JawaharLal Nehru Stadium Complex, Indira Gandhi Stadium Complex, Major Dhyan Chand National Stadium, Dr. S P M Swimming Pool Complex, Dr. Karni Singh Shooting Range) is being carried out by CPWD since the conclusion of CWG-2010 in October, 2010. CPWD vide its letter no. CWGP/CE(C)/23(15)/1359 dated 04-12-2010 submitted an estimate of Rs. 3.42 crore for the month of November and December, 2010 and another letter No. CE(C)/CWGP/23(15)/2010/1451 dated 21-12-2010 giving an estimate of Rs. 6,70,92,515/- for a period of three months starting from January, 2011 to March, 2011. 3.0 As per Para 118 – 119 of CPWD code, CPWD takes up the deposit work when full estimated cost of the work as worked out by CPWD including Departmental Charges will have to be deposited by the client department before the work is taken up for execution. No interest will be paid by CPWD to the client department for such deposit.

4.0 As per the delegation of financial powers, DG, SAI has the power to sanction Rs. 1.00 crore in each case in regard to Maintenance work of existing infrastructure / building / Stadium/ Play-fields provided execution work is entrusted to CPWD through deposit works.

**Enhancement of Delegation of Financial Powers to DG,SAI for Delhi Stadia**

The five SAI Stadia Complexes, namely, Jawaharlal Nehru Stadium Complex, Indira Gandhi Stadium Complex, Major Dhyan Chand National Stadium, Dr. S P M Swimming Pool Complex and Dr. Karni Singh Shooting Ranges, were up-graded/renovated for CWG-2010 after spending a considerable amount. At present, these stadia complexes are being maintained through CPWD/NDMC/Government undertakings etc. Presently, DG, SAI has been delegated the financial powers of Rs. 1.00 crore in each case for the following:

- a) Maintenance of existing infrastructure /buildings/stadiums/playfields etc. provided execution works is entrusted to CPWD/State PWD/Other Government Agencies/Public Sector Agencies through Deposit works
- b) Maintenance of existing infrastructure /buildings/stadium/playfields etc. through any reputed construction agency or private contracts duly registered with CPWD/PWD/MES/Railway (as departmental works) through open competitive tendering/Departmentally

2.0 The existing delegation of Financial Powers is not sufficient for smooth Operation and Maintenance of SAI stadia at Delhi as almost all proposals involving operation and maintenance of stadia complexes exceed the present power of DG, SAI and all such cases are required to be placed before the Finance Committee for concurrence and then for the approval of Governing Body of SAI. This can hamper the day to day operation and maintenance work. In order to avoid such situation, the existing financial powers of DG, SAI may be enhanced to "FULL POWERS" only in respect of (a) above. No change is proposed for (b). These powers will be exercised subject to the availability of
