In case, any team member is covered under the above Act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to Tashkent, Uzbekistan.
- 4. Such of the team-members who might be Central Government Servants are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.1.1989. The Federation should inform their employing Department/Office accordingly.
- 5. It is requested that Embassy of India, <u>Uzbekistan</u> and organizers of the event may please be informed by fax/e-mail of the travel plans and itinerary of the team for participation in the
