


Subject : **Creation of the Special Project Division**

The Director General, Sports Authority of India hereby approved the creation of Special Project Division. Any project specifically assigned to the Special Project Division will be handled by SP Division. The Incharge of SP Division will be Secretary, SAI. SP Division may directly interact with NSF, State Government, MYAS on behalf of SAI rather than routing through various other Divisions of SAI. SP Division can take necessary assistance from Infra Division or ES Division as deemed fit. Once operational modal is finalized, the same will be assigned to concerned division. The due approval of DG, SAI may be taken wherever needed.

Project assigned

- (i) Ahmedabad Olympic Infra Development including Naranpura
- (ii) Banaras – Infra and operational model at Sigra (sports school and Centre of Excellence will be handled by SLKIC)
- (iii) Trivandrum Golf Course (all matters)
- (iv) Stadia, SAI Centres – all projects related PPP and optimum utilization of assets, especially Stadia, arrangements with service providers for sports (Siri Fort model).
