# **CIRCULAR**

Sub: Policy for Pre Induction Assessment Camps for selection of athletes for SAI NCOEs-reg.

The athletes in NCOEs are inducted on pan India basis through the Talent Identification and Development Committee (TIDC) comprising of eminent Arjuna Awardee Athletes, Dronacharya awardees coaches etc. The TIDC screens athletes from various championships and through selection trial etc. and draws a long list of athletes. This is to be further pruned down after 03-10 days Assessment Camp by TIDC and this process takes some time. However, the pre-induction assessment camps are not held while selecting the athletes for SAI NCOEs. This leads to multiple issues like induction of injured athletes, some athletes do not join and selection of athletes with poor skills not suitable for NCOEs.

Therefore, the Governing Body in its 60<sup>th</sup> meeting held on 08<sup>th</sup> August, 2024 has approved holding of assessment camp of minimum of 3 days and a maximum of 10 days as per the Khelo India protocols for final selection of athletes for NCOEs.

The assessment camps may be held annually as the induction calendar for NCOEs has been standardized. The financial norms will be same as stipulated under Khelo India vide Notification dated 24.12.2021 for holding assessment camps (annexed). Further wherever possible, funds through CSR Partners may be utilized for the assessment camps for final selection of athletes for NCOEs.

Expenditure Norms for Selection trials/camps and Performance Assessment Camps for Talent under Khelo India Talent Development.

As per the approval of 10<sup>th</sup> High Power Committee (HPC) Meeting dated 14.12.2021, it is hereby notified the expenditure norms for Selection Trials/ Assessment Camps for talent identification and the Performance Assessment Camps for Talent under Khelo India Talent Search and Development vertical of Khelo India Scheme. The details are here under:

1	Lodging	Rs 300/day Rs 480/- per day* AC III Tier or as per actual subject to max of AC III tier in the shortest route. (In case of the journey is more than 1200 Km/18 hrs., approval may be granted at the level of DG SAI for Air travel in special circumstances)

4	Miscellaneous (local travel)	As per Actuals- travel by public transport/share taxis		
5	Medical	As per Actuals		
6	Age Verification Test (AVT) Charges	Rs 500/- per Athlete		

(\* If trial/camp is conducted at SAI, the boarding charges will be as per actual)

- 2. These norms will be applicable to the selection trial camps being conducted after initial screening/shortlisting on the recommendation of authorized committee/state agency/respective NSFs and are not applicable for open selection trials being conducted for grassroot talent identification.
