Sports Authority of India (SAI), under Ministry of Youth Affairs & Sports (Government of India) envisages to broad base and to bring excellence in Sports across the country. SAI has 12 Regional Centers, 23 National Centre of Excellence, over 65 State level Khelo India Centers, etc. SAI is planning to create state of the art high performance centre including sports science, rehab and recovery facilities. Therefore SAI intends to call for competition for a standard design of disabled friendly high performance centre in G+1 configuration.

In this line, the competition will be among the SAI empanelled consultants for the submission of creative designs. The entries may be submitted on e-mail infra-sai@gov.in latest by 16.03.2021. The winning entry will be awarded cash prize of Rs. 75,000/-.

The broad scope of design should consider the following features

- Rehabilitation Centre
- Recovery Centre
- Dope Room
- Gymnasium
- Physiotherapy facilities
- Psychology centre
- Warming up track (Min 30 metres)
- Sports Science and evaluation
- Other facilities/space requirements associated with such facilities to include reception, change room, with Air conditioning, fire alarm, wet riser fire fighting arrangements etc.

The design should cater the needs of 300 athletes at a time.

Annexure-I

A. Selection Process

1. All entries received by the stipulated date and found in order, shall be evaluated by a Selection Committee, constituted for the purpose. The Committee will shortlist the entries and will decide the winner if an entry is found suitable. All participants are requested to attend a meeting scheduled to clarify queries on 11th March 2021 at SAI Head Office.
2. Entries would be judged on the basis of elements of creativity, simplicity, technical excellence, artistic merit and visual impact and how well they communicate the concept.
3. The decision of the Selection Committee would be final and binding on all the contestants and no clarifications would be issued to any participant or on any decision of the Selection Committee.
4. Participants will have to make a presentation before a committee and the evaluation criteria for selection of the creative /proposal is as follows:

5. There will be only one winner of the competition and SAI will have the right to modify the selected design.
6. Winner shall be required to provide the original open-source file of the design, which shall be the property of SAI.
7. Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to local jurisdiction of Delhi State only. Expenses incurred for this purpose will be borne by the parties themselves.
8. SPORTS AUTHORITY OF INDIA if it so decides, reserves the right not to proceed with the competition at any stage.

B. Terms and Conditions.

- i. Colored copies design should be submitted in DWG, DXF, and CDR.
- ii. Façade should have a suitable designing feature with SAI Logo

- iii. The design should be designed on the digital platform. It is required to submit the design in open file format (DWG/DXF/CDR). Participants should ensure that original designs are submitted.
- iv. Entries should not be submitted in compressed or self – extracting formats.
- v. Each entry should be accompanied by a brief explanation of the design and how best it encapsulates its essence.
- vi. All entries must be submitted through email only at infra-sai@gov.in.
- vii. The design must be original and should not violate any provision of the Indian Copyright Act, 1957 or the Intellectual Property Rights of any third party. The design should not have been previously published in any print and digital media and must not contain any provocative, objectionable or inappropriate content.
- viii. In case of any copy right issues, the participant will be responsible to settle any legal proceedings arising out of it at his/her end. SAI will not be responsible.
- ix. All entries are governed by the provisions of Emblems and Names (Prevention of improper use) Act, 1950 and any violation of the said Act will result in disqualification.
- x. All entries will be property of SAI and may use entries as and when required.
- xi. SAI takes no responsibility for corrupted or late submission.
- xii. **INTELLECTUAL PROPERTY RIGHTS (IPR):**
 - a. The winning design would be the intellectual property of the SAI and the winner shall not exercise any right over it. SAI will have unfettered right to modify the prize - winning design/entry or add/delete any info/design feature in any form to it. The winner will not exercise any right over his/her design and shall not use it any way.
 - b. Winner shall be required to provide the original open source file of the design, which shall be the property of SAI.
 - c. It will be the responsibility to ensure that the entries are original and does not have any copy right issue. Any such issue, if arises, the agency shall be responsible.
 - d. All the submitted designs will be the property of SAI.
- xiii. Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to local jurisdiction of Delhi State only. Expenses incurred for this purpose will be borne by the parties themselves.
- xiv. Payment to the winner will be made through electronic mode for which the necessary bank details will be taken after the declaration of winner of the contest.
