Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration
2. Buyer Added text based ATC clauses

The service is to be provided across 5 stadium in Delhi i.e., Jawaharlal Nehru Stadium, Indira Gandhi Stadium Complex, Major Dhyan Chand National Stadium, Dr. Syama Prasad Mookerjee Swimming Pool Complex and Dr. Karni Singh Shooting range. Stadia wise details are given in buyer added ATC Document.

Please Note the evaluation is based on Least Cost Selection method. The Eligible bidder must get a minimum of 70 marks (out of 100 marks) in the Technical Evaluation as per Evaluation Criteria to proceed to opening of Financial/Price bid. For Detailed Qualification Criteria, Technical Evaluation Parameter, Scope of Services and all other terms and conditions of the bidding document. please refer buyer added ATC document.

Bidders to quote financial bid only as per the format given at ANNEXURE 'IX' of the buyer added ATC document. Financial bid in any other format may lead to rejection of Bid. Also, the uploaded file shall not be a part of technical Bid. Submission of Financial Bid as a part of technical bid will lead to rejection of bid.

The bidder shall submit all the requisite documents carefully as the bid will be evaluated on the basis of submitted documents only and no clarifications will be sought from any bidder.

MSMEs (under relevant category) and verified Startups (under relevant field) will be given exemption only for EMD, upon submission of the Bid Security Declaration as per format given in buyer added ATC document along with relevant notification(s) with required documents.

Please refer Buyer added ATC Document for corrigendum against the tender document.

The bidder shall submit an undertaking that the bidder has quoted the rates as per minimum wages act for skilled, semiskilled and unskilled manpower as per format at **Annexure-XVII of buyer added ATC documents. Non-submission may result in rejection of the bid.**

Disclaimer

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
