





# MINUTES OF THE DEPARTMENTAL PROJECT APPROVAL COMMITTEE - MEETING HELD ON 21.11..2019

The decisions taken during the meeting are as under :-

#### Agenda Item No. 1: Khelo India University Games 2020

The Committee accorded in principle approval for organizing competitions of universities in collaborations with AIU, State Government of Orissa and KIIT University to be called "KHELO INDIA UNIVERSITY GAMES".

The competitions may be held from 22<sup>nd</sup> February, 2020 in 16 sports disciplines (**Individual Events** - Archery, Athletics, Boxing, Fencing, Judo, Swimming, Weightlifting, Wrestling **Team Games** - Badminton, Basketball, Football, Hockey, table Tennis, Tennis, Volleyball and Rugby).

The details of budget and responsibilities of each stakeholder may be decided in consultation with Department of Higher Education, Ministry of HRD, Govt. of Orissa and put up to the Committee subsequently.

# Agenda Item No. 2: <u>Proposal from Cycling Federation of India (CFI) regarding</u> resurfacing track area of Velodrome at LNIPE, Guwahati for Khelo India Youth Games (KIYG) 2020

The proposal was ratified by the Committee.

# Agenda Item No. 3 : Proposal for financial assistance of NADA for conducting testing awareness campaign during KIYG 2020

The Committee decided that the Dope tests are to be undertaken by NADA. The funds for the same will be provided by the Department of Sports. Accordingly, NADA may seek approval for the same on file.









#### Agenda Item No. 4: Budget of Time and Scoring Result (TSR) for KIYG 2020

The total budget of Rs.2.26 crores for TSR system was approved and DG, SAI has been authorized to release funds to NSFs for procuring TSR system.

### Agenda Item No. 5: <u>Budget Estimates – Additional factor due to increase in budget of Apparel.</u>

The Committee noted that the earlier procurement proposal was for KIYG 2020, NCOEs and Khelo India Athletes whereas now it includes the requirement of proposed KIUG as well. There has been increase of quantity by 100%. Therefore, the Committee approved the increase of cost of apparel to Rs.20.00 crores plus taxes as applicable from earlier approved amount of Rs.10.00 crores.

# Agenda Item No. 6: Financial Implication for distribution of cash awards to medalists of Khelo India Youth Games (KIYG) 2020

The Committee noted that in future each year there will be four competitions under Khelo India Scheme. Therefore, in view of huge financial implication for providing cash award for such competitions, the concerned State Government should be requested to contribute for meeting the expenditure towards distribution of cash awards to the medalists.

### Agenda Item No. 7: Engagement of Human Resources in Khelo India.

The item was discussed and approved.

# Agenda Item No. 8: Requirement of funds for non-regional centres of SAI and extension centers of STC/SAG

The item was discussed and it was decided that all remaining 23 SAI Training Centers should be funded under the Khelo India from 1<sup>st</sup> December, 2019.

### Agenda Item No. 9: Proposal for conduct of State & District level competitions by the NSFs under the Khelo India Scheme "Promotion of Sports among Divyang Persons"

The item was discussed and it was decided that the proposal should be discussed during the ACTC meeting..
