DetailedDescriptionofAgenda:

Khelo India scheme is the flagship programme of the Government of India to revive the sports culture in the country at grassroots level by building a strong framework for all sports played in the country and promotes achieving sporting excellence at the highest level. To accomplish the above objectives, Khelo India programme has been divided into 5 verticals.

Out of the 12 components spread across these 05 verticals, following components are handled by SAI & MYAS for implementation through various partners :

The implementation of the above verticals has started in full-fledged manner as the scheme has entered its fifth year. With respect to above projects, MYAS &SAI undertakes number of tasks as part of implementation such as monitoring, coordination, handholding, technical inputs, release of funds, settlement of Utilization Certificate (UCs), sensitization, ensuring timely information dissemination etc.







The implementation of these verticals involve multiple stakeholders like State government, accredited academies (private and State), NSFs, Kendirya Vidyalaya Sangathan, Army Boys Sports Companies and others with expansive geographical presence across the length and breadth of the country. Currently under Khelo India Scheme 884 Khelo India Centres (KICs) have been setup in more than 650 districts along with 76 KIC's in collaboration with Indian Railways and, 31 KISCE's have been setup in 30 States/UTs. Also, 294 academies have been accredited across the country which includes SAI, NON SAI, State run as well as Private Academies. Out of 37 States/UTs, 31 States/UTs are actively involved in setting up of Khelo India Centres and academies. Further, support for training including Out-of-Pocket Allowance (OPA) has been provisioned for 3000 Khelo India Athletes under the Scheme.

In addition to the above, the no. of events conducted under components like FIT India and Sports competition & Talent Development and Promotion of inclusiveness through sports have also substantially increased. In the next one year there is plan to operationalize all 1000 Khelo India Centres, Conduct the first ever Khelo India Para Games and also extend technical support to the States and UTs through knowledge transfer.

Further under the Sports for women component the women leagues are being conducted across various Sports Disciplines. Also the components with nation-wide implementation like capturing of physical fitness data of school going children, national level talent identification program etc. are also in pipeline. This would entail physical monitoring of centres/ programmes at the district level to get the desired result. Further, in hosting the Khelo India Games, SAI and its Regional Centres are involved in technical conduct, financial assistance to Host State, release of funds to the States/UTs for travel grants and also settlement of the advances released for the purpose as well as extending support in the form advice and guidance and necessary handholding.

In addition to this under the "Creation & upgradation of Sports Infrastructure" vertical of Khelo India financial assistance is extended to States/UTs and other eligible entities for creation & upgradation of infrastructure. More than 130 infrastructure projects are ongoing which require close supervision and monitoring.

In the light of the above, it is pertinent to note that in view of the spread and expanse of the Khelo India Scheme and also the increasing involvement of Field Units of SAI as well as State/UTs it is imperative to put in place a robust Monitoring mechanism manned by sufficient number qualified professional working under the supervision of officials of SAI/ State/UT. In this regard reference is drawn to Clause 1.6 of the Gazzette notification of the Khelo India Scheme dated 4th March, 2022 wherein Rs 5 crore has been earmarked for the overall administration and monitoring of the scheme which inter alia involves engagement of consultants for monitoring of progress of the component. Further reference is drawn to Clause 1.5 related to Monitoring & Evaluation, where-in it is mentioned that a robust monitoring mechanism will be set up to measure and review output/outcomes of Khelo India scheme on a periodic basis.

Accordingly, requirement of 100 resources have been estimated for monitoring of Khelo India projects across the country. This assessment has been made by considering the number of district-level KICs, KISCEs, accredited academies, ongoing infrastructure projects and a reporting hierarchy. The following organogram depicts the structure and no. of resources:







National Head (01)

Zonal Heads (06)

State Heads (14)

Young Professionals (79)

The above requirement has been projected after considering the quantum of work in a particular State/UT and post bifurcation of 36 State/UTs into 06 zones. The detailed calculation sheet is placed at Annexure-I. Between 01-03 YPs have been considered every State/UT, who will report to State heads (managing multiple States/UTs) who in turn will manage 04-06 YPs under them. Further, 06 zones will have a Zonal head each who will report to National head. Thus, a total of 100 resources would be required for efficient implementation of Khelo India scheme, for which DG SAI may be authorized to finalise the bifurcation of YPs required in States/UTs based on actual requirement of YPs with administration, legal, accounting, etc. backgrounds. Their deployment would be as per requirement in various offices of SAI, including SAI Head Office along with deputation at dept. of sports across various States/UTs which may also be decided at the level of DG SAI.

The remuneration for the posts and as well as qualifications have been calculated as per NITI Aayog norms. The overall annual financial implication for 100 resources totaling to approximate Rs. 7.47 cr. (at lower band). The enhancement in remuneration as per NITI Aayog guidelines shall be upto a maximum of 10% p.a. if continued beyond one year. Moreover, the estimated Out-of-pocket expenditure (OPE) shall be restricted to 15% (reference from NICSI contracts) of the overall annual financial implication which comes out to Rs. 1.12 cr. The above-mentioned proposal may be approved coterminous with the scheme. However, the estimated budget may be approved on annual basis as a part of operational Expenditure.

The mode of hiring may either be through direct hiring (through SAI RCs or H.O.) or engaging a suitable manpower agency for providing 100 resources across the country. The deployment of the proposed manpower in the State/UTs/SAI RCs may be decided by DG SAI as per functional requirement and necessity.

Approval of the DPAC is solicited for:

i. Engaging 100 resources under Khelo India scheme with annual financial implication of Rs. 8.59 cr. where-in Rs. 7.57 cr. is for engaging 100 resources and Rs. 1.12 cr. is for OPE. The approximate financial impact for FY 2023-24 is estimated to be Rs. 2.5 cr.

DetailedDescriptionofAgenda:

The Khelo India Centre (KIC) component under the Khelo India Scheme has twin objectives:

- i. Providing sports training/coaching to willing children
- ii. Providing a sustainable source of livelihood outside the government set-up to past champion athletes.

KICs are expected to be nurseries for sports talent, the progression of athletes to SAI Training Centres (STCs), National Centres of Excellence (NCOEs), Khelo India State Centres of Excellence (KISCE), states managed academies, private academies, participation of athletes in Khelo India Youth Games and other similar parameters would be utilised to analyst the performance of KICs. It is pertinent to conduct capacity-building exercises to empower the Past Champion Athletes to achieve this. The capacity-building exercise would help Past Champion Athletes (PCAs) inculcate correct techniques at the grassroots level. In this regard, reference is drawn to clause no. I (iv) under section 1.3.3 on page number 07 of the Khelo India Gazette notification, where-in it is mentioned that capacity building and viability gap support will be provisioned for State Centres of Excellence and Khelo India Centres.

As of now, around 700 PCAs have been hired across the country. Of 700 hired PCAs, 205 PCAs need a refresher course, which is 30 % of hired PCAs. Assuming this ratio, the following budget is proposed for the capacity building of 1067 PCAs (1000 KICs, including new and converted KICs).

- 2. SAI conducted multiple deliberations through Video Conferencing meeting with the State Sports Department, Bihar and SAI RC Kolkata to assess the critical gaps.
- 3. Assessments have been done for sports science equipment, manpower and sports equipment (consumables and non-consumables) for KISCE in the State of Bihar.
- 4. Accordingly, the budget requirement for the above-mentioned KISCE has been assessed keeping in mind the importance of developing the centre as KISCE. The breakup is as mentioned below.

Khelo India State Centre of Excellence (KISCE) is a project which is a part of India's pursuit for excellence in Olympics and endeavor is to scale up State's best academies to world standard.

In this regard, proposal was received from UT of Ladakhvideletter no. Secy.Adm/UTL/SLKIC/2023-23/07-110 dated 28.04.2023 from the OSD to the Secretary, Sports Department, regarding the establishment of Khelo India State Centre of Excellence (KISCE) in the UT of Ladakh at Open Stadium Spituk/Lamdon Archery Field/Boxing Hall at Leh for the disciplines of Athletics, Archery and Boxing.

DetailedDescriptionofAgenda:

Reference is invited to the gazette notification for continuation of the scheme of Khelo India-National Programme for Development of Sports for financial years 2021-22 to 2025-26 wherein under Para 1.3.3 (II) it is stated that under the component 'Khelo India Centres and Sports Academies' and sub-component 'Support to National/Regional/State Sports Academies' states that the identified sports talents will be given the option to join SAI National Sports Academies, State Sports Academies or Sports Academies established by the private sector. Further, Grants-in-aid will be provided for establishment, operation and maintenance of sports academies in respect of identified disciplines to Sports Authority of India, and other stakeholders for facilitating and supplementing Long Term Athlete Development (LTAD) programme (for 8 years) on need-based support, both recurring and non-recurring.

- 2. The Scheme provides a mechanism of funding Academies for meeting critical infrastructure gaps, including equipment. As on date, 74 Academies are established by Sports Authority of India (SAI) through its 23 NCOEs. 804 Khelo India athletes (KIAs) across the country in 24 identified sports disciplines are undergoing training at various NCOEs for which the entire expenditure is met from SAI Block Grant. Many of the athletes of these centres are part of the National Coaching Camp and Indian Teams for various competitions. These academies are considered as a regular academy where the training can be given even when there is no National Coaching Camp which will ensure the continuity of training.
- 3. After the Cadre Restructuring, SAI posted many scientific officers in its various scientific departments in all these NCOEs. Over the last 3-4 years a considerable improvement has been made in the accommodation and the Field of Play of these NCOEs. As the next essential step for strengthening these academies under NCOE, it is felt that there is a need of providing Sports Equipment and Sports Science Equipment of International standard which will ensure the smooth training, reduce the possibility of injury, help athletes in rehabilitation, easy recovery and achieve desired results. An effort was made to identify the requirement of such Sports Equipment and Sports Science Equipment across the academies under 23 NCOEs. A consolidated list of Sports Equipment and Sports Science Equipment for each discipline depending upon the strength of athletes training is enclosed at **AnnexureIV-A** (Sports Equipment) and **Annexure IV-B** (Sports Science Equipment).







- 4. After making the gap analysis on availability and the essential requirement of these academies, it is felt that Sports Equipment worth Rs. 11.72 Cr. and Sports Science Equipment worth Rs. 35.19 Cr. is essential for strengthening these academies. Procurement of these equipment could be completed in the next 03 months followed by 02 months for the delivery. It is expected that these equipment can be made operational in all the academies under NCOE by the end of December 2023. Procurement shall be made by strictly following the procurement procedures as per the GFR by the respective NCOE.
- 5. DPAC is further informed that the agenda w.r.t. procurement of consumable and non-consumable equipment for STCs and NCoEs was placed in 37th DPAC dated 21.11.2022 where-in it was decided that the agenda may be referred to MDSD, MYAS for concurrence for budget availability before placing in the subsequent DPAC meeting.
- 6. In the above circumstances, it is proposed that a sum of Rs.11.72 Cr. for Sports Equipment and Rs.35.19 Cr. for Sports Science Equipment totaling to Rs.46.91 Cr. (non-recurring) may be considered for funding under the Head 'Assistance to National/Regional Academies'.

Approval of the DPAC is solicited for:

i. Financial approval of Rs. 46.91 cr. for procurement of non-consumable sports equipment (Rs. 11.72 cr.) and procurement of non-recurring sports science equipment (Rs. 35.19 cr.) for sports academies being NCoEs

DetailedDescriptionofAgenda:

Under the component of Sports Competitions and Talent Development of Khelo India Scheme mentioned in the Gazette Notification dated 4 March 2022. It is mentioned that the Central Government willorganize National-level competitions, i.e., Khelo India Youth Games and Khelo India University Games, in respect of high priority/priority sports disciplines. So far 8 editions of Khelo India Youth and University Games and 3 editions of Winter Games have been successfully conducted so far. Further, the next edition of Khelo India Youth Games (KIYG), is scheduled to be held in the State of Tamil Nadu and the next edition of Khelo India University Games (KIUG) is scheduled to be held in the State of Assam, whereas the next edition of Khelo India Winter Games 2024 is scheduled to be held in the UTs of J & K and Ladakh. Furthermore, the 1st edition of the Khelo India Para Games is planned to be conducted in Delhi in 2023 in 7 Sports disciplines.

- 2. In the above context it is pertinent to note that in organizing the games it is ensured that the technical conduct is benchmarked to international standards. The use of technology-driven initiatives such as Online Registration through NSRS, Time Scoring and Result (TSR), Games Management System, Facial Recognition, Certificates through DigiLocker along with the best of the Accommodations, Transportation, Nutritious Food and Apparel ensure that the athletes are exposed to international standard exposure in a domestic environment. These Games helps in promoting the culture of sports, and citizen engagement and also provide a platform for talent identification.
- 3. For the successful organization of the games and for maintaining the standard of the games and brand value an estimate has been prepared for the Khelo India Games which also takes into account the factors such as Number of Venues, Sports Disciplines, Participants including Athletes etc. The details are as follows:

4. It may also be noted that **Rs 65 Cr** was approved for KIYG 2023 and KIUG 2023 both in the **39th DPAC** meeting dated **27.7.2023**. Further, the Head-wise expenditure is proposed in the above-mentioned table (*Columns 3 & 4*).







- 5. It is submitted that preparing the estimate of Khelo India Winter Games 7 sports have been taken into consideration, however if the number of sports discipline gets reduced the estimate will also reduce accordingly and the same shall be placed before DPAC for its information. Further, the estimated budget for Khelo India Winter Games also includes likely expenditure to be incurred on Accommodation, Catering & Transport.
- 6. In view of the above, the following are placed before DPAC for necessary direction
 - Broadcasting and Production along with monetizing rights may be given to the Host State in case of Khelo India Youth, University, & and Winter Games. Accordingly, the estimated expenditure will get reduced.
 - **KIWG 2024**: The Financial liability for the Khelo India Winter Games may be distributed among the Host State and SAI. Host UTs may be asked to bear the expenditure for Accommodation, Catering & Transport and in that case the estimated expenditure will also get reduced accordingly.

Approval of the DPAC is solicited for:

- i. Approval for the estimated budget of Rs. 103.8 crores towards Khelo India Games (KIYG 2023, KIUG 2023, KIUG 2023, KIWG 2024) to be debited under the "Sports Competition and Talent Development" Vertical of Khelo India.
- ii. Authorizing DG for incurring expenditures upto 10% above the approved budget and reappropriate funds from one head to another head of expense within the approved budget.
