4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

6. Buyer Added Bid Specific ATC

Terms and conditions:

- 1) Service provider is required to pay salaries / wages of contracted staff deployed at buyer location first i.e. on their own which can be up to three months and then claim payment from buyer along with all statutory documents like PF, ESIC challan PT etc. as well as the bank statement of salary to staff along with salary slip. The service provider should not make any other deductions such as contribution to society, caution deposit etc other than the statutory deductions.
- 2) Bidder should have its Geographic Presence: The bidders should have a registered office situated in the State of Maharashtra, near to SAI NCOE Aurangabad i.e. in Municipal Corporation of Aurangabad (Chhatrapati Sambhajnagar) or District Aurangabad (Chhatrapati Sambhajnagar) (Maharashtra).
- 3) The bidder should provide contract labour license for providing Security guards service as per the CLRA Act 1950 from Shram Suvidha portal or Maharashtra Contract Labour (regulation and Abolition) Act, 1971. They should submit copy of Shram Suvidha CLC Annual Return in case of CLRA Act 1950. The bidder must provide license under PSARA act 2005.
- 4) Copy of Annual Turnover not less than 60 lakhs for last 3 years turnover certificate.
- 5) Bidder must ensure the submission of similar work order from any of the State / Central Government organizations.
- 6) Solvency certificate minimum 23 lakhs from bank (not above six month)
- 7) Should furnish valid ISO certificate for providing Security guards services
- 8) Should have minimum 3 years experience in providing Security guards services
- 9) Should submit minimum wages compliance certificate from the current client stating that the contractor is paying wages in accordance with minimum wages notified by the Chief Labour Commissioner Central to the employees engaged in various day-to-day activities.
- 10) Should submit proof of remittance of ESIC, PF, GST etc.
- 11) Should have registered under GST Act.
- 12) ITR for past 03 years along with balance sheet and profit & loss statement (FY. 2020-21, 2021-22 and 2022-23)
- 14) Current client list with contract details.

- 15) The service provider is required to have at least 50% of the required Security Guards services provider payroll for at least one year. Necessary documents relating to such Security Guards service will be uploaded by the bidder for verification of the buyer.
- 16) Undertaking regarding not blacklisted or debarred by any Govt. entity (format enclosed)
- 17) Successful bidder needs to provide police verification certificate, medical fitness certificate and address proof of the engaging manpower to SAI, NCOE Aurangabad.

8. Purchase Preference (State)

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
