2. The required manpower for lifting the items to be arranged by the bidder himself/herself at his cost.
3. The interested bidders will have to submit Demand Draft of **Rs 1,000/- (Rupees One Thousand Only)** as security/EMD in favour of **Centre Incharge, SAI NCOE Dharamshala** and payable at Dharamshala to the following address:

4. The Condemned **Store Items** can be inspected only on any working day from **26/10/2024 to 05/11/2024** between 11:00 am to 3:00 pm.
5. The entire sale/bid value with applicable taxes shall be deposited by the highest bidder within 10 Days from the date of issue of sale letter.
6. The possession of Condemned **Store Items** will be given to highest bidder on the receipt of full amount of bid value after completing all the formalities.
7. The highest bidder/purchaser will have to remove the Condemned **Store Items within 10 working days** at their own cost from the date of receipt of entire sale/bid value from the highest bidder.
8. In case, if the highest bidder does not lift the Condemned **Store Items** within 10 working days, the bid security/EMD deposited by him shall be forfeited without any communication. Thereafter, Condemned **Store Items** will be offered to the second highest bidder at the price offered by highest acceptable bidder.
9. The highest bidder will have to deposit GST@18% or RATE as applicable on the entire auctioned amount with the concerned authority and the deposit slip shall be submitted in the office of the Centre Incharge, SAI NCOE Dharamshala before lifting the Condemned **Store Items**.
