Revision of Travelling Norms for Athletes of STC Kargil

Sports Authority of India is implementing various sports promotion schemes across the country to identify talented sports person and nurture them to excel at national and international level. In pursuance of this objective, SAI training Centres (STCs) are currently being run in order to cater to the needs of talented athletes in the Junior and sub-junior age group in 27 sports disciplines.

Presently, there are 64 STCs with a total sanctioned strength of 4824 (3846 Residential and 978 Non-residential). The athletes are imparted training by expert coaches and provided with facilities like Boarding, Lodging, Sports Kit, Competition Exposure, Educational Expenses, Medical and Insurance, Stipend etc.

Geographical and Logistical Challenges in Kargil

It has been observed that major sports competitions are typically held in mainland India. Athletes from the Union Territory of Ladakh, particularly those from STC Kargil, face significant logistical challenges in attending these competitions due to the region's unique geoclimatic conditions.

- **Rail Connectivity**: STC athletes in Kargil do not have access to train services. The nearest railway station is in Jammu, approximately 462 km away. Under normal conditions, the road journey takes about 15 hours. However, during the winter season, due to traffic congestion at the Zojila Pass, the travel time may extend up to 25 hours.
- **Air Travel Limitations**: Air travel is the only viable alternative, but limited flight availability and high airfare make it difficult for athletes to travel conveniently. This often leads to missed training sessions and fatigue before competitions, adversely impacting athlete performance.
- Winter Isolation: From December to May, Kargil remains cut off from the mainland due to heavy snowfall. The nearest airport is in Leh, approximately 230 km away.

During this period:

- A shared taxi to Leh costs ₹3,000 per person.
- Airfare between Leh and the mainland ranges from ₹12,000 to ₹15,000 (sometimes reaching ₹20,000).
- Estimated total minimum travel cost to Jammu per person in winter: ₹30,000.

• Non-Winter Travel Costs: In other months, shared taxis are the primary means of transport to Jammu, costing around ₹3,000 per person, from where train journey is to be undertaken.

• Total estimated travel cost to Jammu per person in non-winter months: ₹6,000.

In this regard, it may be noted that the Governing Body of SAI in its 60th Meeting held on 09th August, 2024 approved the revision of travelling expenditure norms for athletes of STCs located in island territories w.e.f. FY 2024-25 as below:

This was made subject to a maximum of 02 competition exposures with ceiling of Rs. 10,000/- per athlete per exposure for island territories under SAI Block Grant w.e.f. FY 2024-25 with athletes being allowed to travel by any mode of transport i.e. air/train/ship within the ceiling.

Hence, it is proposed that athletes from STC Kargil be brought within the purview of travelling norms approved for island territories by the 60th GB. Financial implication on account of revision of norms for athletes of STC Kargil is provided below:

The Finance Committee of SAI concurred the proposal in its 124th meeting held on 29th April, 2025 with recommendation to put up before Governing Body for approval.

Approval of the Governing Body is solicited for allocation of an additional amount of ₹8,40,000/- for Athletes of STC Kargil annually for Competition Exposure of SAI Scheme Athletes.

Waive of Booking Charges to Ministry of Defence (MoD) for booking of J.N. Stadium and MDC National Stadium, New Delhi

Ministry of Defence (MoD) had requested for making available the parking space at J.N. Stadium and organizing the Grand Finale of the National School Band Competition at MDC National Stadium respectively as associated event of the Republic Day Parade from 13th to 26th January, 2025.

2. As per SAI approved tariff, charges have been calculated, which may be charged from Ministry of Defence for parking and holding the Grand Finale of the National School Band Competition at JNS & MDCNS: -

4. In this regard, Shri Rajesh Kumar Singh, IAS, Defence Secretary, Ministry of Defence vide DO No. 1(1)24/2024/D(CER) dated 02.01.2025 mentioned that Ministry of Defence being the nodal Ministry organizes the functions of national importance like Republic Day Celebrations and Independence Day Celebrations and National School Band Competition. National events like Republic Day Ceremony (RDC) are organized by the MoD in collaboration with multiple Ministries/Departments. All the supporting Ministries/Departments either exempt these charges or absorb these expenses within their own budget. Therefore, charging fees for the use of the buildings/services/spaces owned by Ministries/Departments/Govt. agencies is not in consonance with the overall spirit of organizing national functions. Keeping this in view, they had requested that MoD may be exempted from booking charges of Rs.40,81,850/- (Rs.23,51,100/- for the year 2025 + Rs. 17,30,750/- for the year 2024) for use of facilities of JNS and MDCNS for the aforesaid national event.

5. The request of Ministry of Defence was placed for approval of the Hon'ble Chairman of Governing Body of SAI i.e. Hon'ble Minister for YA & Sports. The same was approved by the Hon'ble Chairman of the Governing Body of SAI on 17.01.2025.

6. Since the approval of Hon'ble Chairman of GB was obtained on file, the same is hereby placed before Governing Body of SAI for Ratification.

Approval of Governing Body is solicited for Ratification of the Waiver of the Rental Charges, Security Deposit and to Refund the deposited charges of ₹40,81,850/- to Ministry of Defence

Revision of Norms & Tariff for booking of SAI Stadia for Sports and Non-Sports Events

The venues of SAI Stadia in Delhi are rented out to various agencies for conducting sports and non-sports events, in accordance with the norms prescribed from time to time. At present, the norms & tariff for non-sports booking being implemented were approved and notified vide Notification No. 25/SAI/SA/Tariff/2015(Vol.-II)/165 dated 24.11.2015 and revised in the 47th Governing Body dated 28.10.2016. Whereas, for sports booking, the orders issued vide Notification No.25/SAI/SA/Tariff 2015 (Vol.-II)/165 dated 25.10.2019 are being followed.

The comprehensive revision of the tariff for the five stadia in Delhi has not been undertaken in 09 years, last being comprehensively revised in 2015-16. During this period, it stands to reason that the market rates have changed considerably and the demand for utilization of the stadia has also increased.

Keeping in view, a committee comprising of the following officials was approved by Director General, SAI to revise the tariffs for both sports and non-sports events:

i.	Secretary, SAI	-	Chairman
ii.	Director (Finance)	-	Member
iii.	Administrator, Dr. KSSR	-	Member
iv.	Administrator, IGSC	-	Member
v.	Administrator, JNS	-	Member
vi.	Administrator, MDCNS	-	Member

Accordingly, a meeting of the Committee was convened on 26.03.2025 to review the existing tariff structure for booking of various spaces across SAI Stadia. Subsequently, a followup meeting of the Committee was held on 21.04.2025 in the Chamber of the Secretary, SAI, wherein a comprehensive assessment of the existing tariff regime was undertaken. The Committee after carefully evaluating all the prospects recommended the revised tariff based on following factors:

- i. Nearly 9 years have been passed, as the last revision of tariff were held in 2016.
- ii. Stadiums' geographical location, socio-economic profile of the surrounding area, patterns of space utilization, inputs received from stadium administrators, availability and quality of supporting facilities, scope for enhanced footfall.
- iii. Prevailing Market Benchmarks: Considering the tariffs of nearby locations like, Siri Fort, Talkatora Stadium, ITPO Pragati Maidan.

Based on this detailed deliberation, the Committee recommended a revised tariff structure that incorporates necessary amendments to better reflect current market realities while ensuring that the rates remain reasonable, equitable, and conducive to wider public utilization of SAI's premier sporting infrastructure. Copy of the minutes of meeting, revised tariffs for **Sports** and **Non-Sports events**, duly signed by the Constituted Committee is enclosed as **Annexure-II & III**.

Further, based on the past experience, it was observed that the booking is being cancelled by SAI and/or agency on account of some unforeseen circumstances viz., cancellation of license by Delhi Police, and important and urgent programme as notified by the Government of India or its agencies, hence in order to deal with these unforeseen circumstances, the following was proposed:

(A) For Sports Category:

a) Cancellation By SAI and /or Organizer: All the decision in respect to waiver of cancellation charges and/or refund amount shall be taken on case-to-case basis, and DG SAI Shall be the competent authority in all such cases.

(B) For non-sports Category:

- a) Cancellation By SAI: All the decision in respect to waiver of cancellation charges and/or refund amount shall be taken on case-to-case basis, and DG SAI shall be the competent authority in all such cases.
- b) Cancellation By Organizer: All the decision in respect to waiver of cancellation charges and/or refund amount shall be taken on case-to-case basis, and Governing Body of SAI Shall be the competent authority in all such cases.

In view of the above, the following proposals were submitted for approval of the Competent Authority (Chairman GB - Hon'ble Minister - MYAS):

- Revised tariff structure for booking of **Sports events**
- Revised tariff structure for booking of Non-Sports events
- Competent authority with respect to waiver of cancellation charges as mentioned in para 8 above.

Since the proposals were approved on file by Hon'ble Chairman, Governing Body of SAI i.e. Hon'ble Minister on 01.05.2025, accordingly, the same is placed before Governing Body for Ratification.

Approval of the Governing Body is solicited for Ratification of the Revision of Norms & Tariff for booking of SAI Stadia for Sports and Non-Sports Events.

Agenda Item No. 6 (a)

Works Required for Hosting the World Para Athletics Championship 2025 at JLN Stadium, New Delhi

The Replacement of Synthetic Athletic Track at JLN Stadium was sanctioned by DPAC Khelo India, MYA&S under Khelo India Scheme on 24.05.2017 at an estimate of Rs. 7.00 Crore.

An Administrative Approval and Expenditure Sanction was issued to M/s WAPCOS Ltd. dated 03.07.2017. The revised tender cost of the work of after the award to the L-1 agency came to Rs. 7.37 Crore on quoted amount which included M/s WAPCOS charges. The site was handed over to agency on 25.02.2020. The revised cost was approved by Competent Authority of SAI.

The work was delayed because of rainy season, and Covid-19 lockdown. The work was resumed in May 2020. Time to time PMG were held and during the PMG meeting dated 29.05.2021 M/s WAPCOS Ltd. had intimated that the work of playing area is almost completed and subsequently undulations were reported in the freshly laid track along underground tunnel in field of play.

In August 2023, a file was received from the Khelo India Division, SAI highlighting the requirement for rectification works as the JLN Stadium was selected as the venue for Para Athletics events during the Khelo India Para Games, held from 8th to 16th December 2023. Consequently, M/s WAPCOS Ltd. submitted a supplementary estimate for addressing these defects, which was subsequently approved in the 58th Governing Body (GB) Meeting, along with an additional financial sanction of ₹1,04,48,848/-, revising the total project cost to ₹8.41 Crore.

However, as rectification required dry weather conditions, only minor repairs could be executed before the Khelo India Para Games. The work was further delayed due to the Indian Super League (ISL) bookings and the subsequent monsoon season.

As on date, the works have been completed excluding the patch work of non-playing area and major rectification of settlement. The work of playing area was completed in May 2021 and is being used for various events (like All India Police Athletics championship, Khelo India Para Games 2023 & 2025) and date to come and play training. Rs. 6.45 Cr. has already been released to WAPCOS till date.

In light of the World Para Athletics Championship 2025, scheduled to be held from 23rd September to 8th October 2025 at JLN Stadium, representatives from the Para Committee of India (PCI) conducted a site inspection in November 2024. Based on their observations, multiple requirement sheets were submitted, detailing necessary modifications, including improvements to the athletic track, warm-up area, accessibility features, and other essential infrastructure improvements to make the venue fully equipped for Para-athletes (Sheet attached at Annexure-IV).

Furthermore, in official communications dated 08.01.2025 and 12.03.2025 (attached at Annexure-V), PCI formally requested the installation of Mondo tracks in both the Main Arena and Warm-up Area, citing international best practices. The World Para Athletics (WPA) guidelines mandate a uniform track surface across competition and warm-up zones to ensure fairness, consistency, and optimal performance. While the existing track, laid in 2021, remains under warranty, it does not meet the specific technical requirements of WPA standards.

To address these concerns, a special technical monitoring committee was constituted to evaluate the feasibility of rectifying the existing track or initiating a new project (**Minutes attached at Annexure-VI**). In the Committee, PCI recommended that in order to meet international standards for the World Para Championship which is scheduled for September 26,2025, the track in the main arena must be replaced. PCI also prefers that MONDO track may be preferred while relaying as it is widely used for international competitions. The existing full PUR track with necessary repair could not meet the standards for hosting international event. Representative of AFI also submitted that the settlement issues need correction and the track need to be replaced for hosting competitions for international standards. Hence, recommended foreclosure of the ongoing work, subject to the approval of the Competent Authority. The proposal of foreclosure of the work was approved in principle by Hon'ble Chairman GB, SAI on file dated 25.03.2025

The committee also recommended the settlement of M/s WAPCOS bills based on the actual expenditure incurred and the formal handover of the site to SAI. Furthermore, it was advised that any track settlement rectification works be undertaken as part of the new relaying project for the World Para Athletics Championship 2025, which was approved by DG, SAI on 27.03.2025.

Approval of the Governing Body is solicited for Ratification for the Foreclosure of project of Replacement of Synthetic Athletic Track at JLN Stadium New Delhi, awarded to WAPCOS on as is basis and for the settlement of pending financial liabilities based on the actual expenditure incurred

Agenda Item No. 6 (b)

Laying of Mondo Athletic Track along with the allied works at SAI JLN Stadium, New Delhi

The World Para Athletics Championship 2025 is scheduled to be hosted from 23rd September to 8th October 2025 at Jawaharlal Nehru (JLN) Stadium, New Delhi. To facilitate the seamless execution of this prestigious international event, infrastructure enhancements have been proposed to align with World Athletics standards and the specific requirements set forth by the Paralympics Committee of India (PCI).

In November 2024, representatives from PCI conducted a site visit and subsequently submitted multiple requirement sheets detailing essential modifications and renovations. These include upgrades to the athletic track, warm-up areas, accessibility provisions, and other infrastructural improvements to ensure the venue is fully equipped to accommodate para-athletes (**sheet at Annexure-IV**).

Further, as per the letters received from PCI on8.01.2025 and 12.03.2025 (attached at Annexure-V),PCI has requested to install Mondo tracks in both competition main arena and warm-up areas as Mondo tracks, used in the Olympics, Paralympics, and World Championships, offer superior speed, traction, and safety. Also, as per World Para Athletics (WPA) guidelines both Main Arena and Warm-up tracks must be uniform surfaces for fair competition and optimal performance.

The existing track, which was installed in 2021, remains under warranty and has not yet completed its service life. However, in adherence to WPA standards and PCI has intimated the track in the main arena must be replaced, the installation of new Mondo tracks is preferred.

In relation to above, the estimates for laying Mondo track for both Main Arena and Warm-up track including other allied works prepared by CPWD received from Administrator, JLN Stadium dated 19th March 2025. The summary of estimates is as follows:

Further, the Engineering Wing shall engage private consultants as Project Management Consultancy (PMC) for preparing the Detailed Project Report (DPR), bill vetting, and other ancillary works. Due to the paucity of time and the unavailability of empanelled private agencies/consultants, the consultation is obtained on a quotation basis.

Additionally, a Proprietary Article Certificate (PAC) Committee has been constituted to issue a PAC certificate before initiating the tendering process, as the Mondo Track is a brand-specific product.

Based on the request from PCI and as directed by the competent authority of SAI, an estimate of ₹52.45 crore (approximately) for the laying of Mondo tracks at the Main Arena and Warm-Up Area, along with other allied works for conducting the World Para Athletics Championship, was submitted for approval. The same has been approved in principle by the Hon'ble Chairman, GB, SAI, on file dated 25.03.2025, and the execution of laying of tracks will be carried out by SAI Engineering Wing.

Approval of the Governing Body is solicited for Ratification of Laying Mondo tracks at both Main Arena and Warm-up Area and other allied works at JLN Stadium New Delhi conducting World Para Athletics Championship. The total estimated cost for these works is ₹52.45 crore.

Establishment of High Performance Centre at SAI NSSC, Bangalore

The Scheme for NCoE was started with an objective to achieve excellence in sports by providing state-of-the-art training facilities to the athletes. At present, there are 24 NCoEs functioning wherein more than 3000 athletes are getting trained.

SAI NCOEs are in the path of immediate expansion targeting strength of 1000 to 1500 trainees per centre in the next five years and accordingly infrastructure (Residential & Sports) are being created. Sports Science is one of the important pillars of NCoEs. Already substantial support in terms of human resource and equipment has been under taken for athletes at these Sports Science Centres. There is a requirement of infrastructure support in Sports science to supplement this proposed increase in NCoEs strength and to ensure optimum utilization of the equipment and manpower.

Non-availability of a dedicated Sports Science centre having all facilities under one roof is a major impediment for efficient utilization of the resources in SAI NCoEs. Presently Sports Science facilities are functioning in segregated, inadequate and make shift places. Therefore, it is proposed to create state-of-the-art integrated high performance centre including sports science, rehab and recovery facilities at various SAI Centres. Further, it is decided to undertake a project at SAI NSSC Bangalore

In this regard, a detailed project report (DPR) along with preliminary estimate of Rs.68,74,13,900.00 (which may vary from preliminary estimate after preparation of detailed estimate) for the establishment of High Performance Centre at SAI NSSC Bangalore under Corporate Social Responsibility (CSR) support from Hindustan Aeronautics Limited (HAL) is prepared.

Rs. 60.00 Cr. grant approved by the board of HAL and the MoU signed between HAL, NSDF and SAI. After identification of PMC for preparation of detailed Estimate, final design and to execute the work, with the approval from competent authority.

Further the above work amounts to Rs.68,74,13,900.00 except GST, ESI, EPF and PMC Charges (Rs. 60.00 Cr. from HAL and Rs. 8,74,13,900.00 under SAI Block Grant/IR)concurred by Finance Division and **in principle approved by Hon'ble Minister of YA&S (Chairman GB SAI) on file.**

The proposal for establishment of Engineering Wing to initiate Direct Tendering for Sports Infrastructure Development at SAI was concurred by 122nd Finance Committee Meeting of SAI dated 15.05.2024 under the Chairmanship of Secretary (Sports) MYAS and the same was approved in 60th Governing Body Meeting of SAI held on 09.08.2024 under the chairmanship of Hon'ble Union Minister of Youth Affairs and Sports.

In view of the above, the work of Establishment of High-Performance Centre at SAI NSSC Bangalore is executed through Engineering wing of SAI through direct tendering process as per GFR 133 (2) and the same is approved by DG-SAI on e-file on 03-03-2025.

Approval of the Governing Body is solicited for Ratification for approval of the work of Establishment of High-Performance Centre at SAI NSSC, Bangalore executed through Engineering Wing of SAI through direct tendering process

Agenda Item No. 6(d)

Consultation for Sports Infrastructure Projects of Government bodies through Engineering Wing of SAI.

Sports Authority of India (SAI), is being approached by various government organizations such as CAPF, NTPC, Noida Authority, NEST etc., to provide specialized consultancy services for the preparation of Detailed Project Reports (DPRs), including design, standards, and preliminary estimates of sports infrastructure projects. This initiative will leverage SAI's expertise in sports infrastructure planning while ensuring high standards in project development.

Under the proposed initiative, SAI will provide consultancy services covering various aspects such as project overview, project timeline, cost estimates, master planning (floor plans and other design details), 3D views and walk-through, stakeholder roles and responsibilities, resource and athlete requirements, and operational running plans. Additionally, it will include architectural designs and drawings, material selection, financial forecasting, feasibility study, implementation strategy, and vulnerability assessment.

The Consultancy Work will be executed partly in-house and partly through empanelled sports consultants. SAI may also engage third-party consultants for technical components, subject to verification by the SAI (Infra) technical team. The final DPR will be coordinated, compiled, and consolidated by SAI before submission to the respective government organization.

The proposal for the establishment of an Engineering Wing to facilitate direct tendering for sports infrastructure development was concurred in the 122nd Finance Committee Meeting of SAI on 15.05.2024 and subsequently approved in the 60th Governing Body Meeting of SAI on 09.08.2024 under the chairmanship of the Hon'ble Union Minister of Youth Affairs and Sports. Additionally, an amendment in the SAI Memorandum of Association (MoA) was approved by the competent authority to include "construction, execution, development, and consultancy services in planning and preparation of DPR, designs, and estimates" as an objective at Point No. 3.

A nominal charge of 0.75% of the total project cost was proposed to be levied for providing specialized sports consultancy services and the same has been approved by the Hon'ble Minister MYAS on e-file on 04-02-2025.

Revenue generated through consultancy services will be deposited under the consolidated internal revenue of SAI. The Finance Division will maintain accounting and include the revenue in the annual statement of accounts of SAI. Since the approval was obtained on file from Hon'ble Minister YAS and Chairman, GB the same is put up before Governing Body of SAI for Ratification.

Approval of the Governing Body is solicited for Ratification for approval of a 0.75% Consultancy Fee on the total project cost for the works to be executed through Engineering Wing of SAI

Centralized Tender for Hiring of an Agency for Provision of Security Manpower for 05 Stadia of Sports Authority of India in New Delhi.

SAI looks after the management and operation of 5 Stadia in Delhi. Accordingly, multiple manpower are required to ensure smooth operations of the Stadia in Delhi. Presently, the services have been outsourced stadia wise. However, it has been felt that it would be prudent if centralized agency for all Five Stadia is to be engaged so as to achieve uniformity in timelines, economies of scale & to hire services of better rated agencies.

An Agenda was put up in the 122nd meeting of the Finance Committee of SAI with a total estimated financial implication of Rs. 20,65,26,638.03/- for 02 years (01 year, extendable by 01 year) incl. of GST. Further, with the concurrence of the Finance Committee, the proposal was approved in the 60th meeting of the Governing Body of SAI.

Accordingly the tender was floated for Hiring of Security Services for a period of 01 year, extendable by 01 year with a total estimated financial implication of Rs. 20,65,26,638.03/-for 02 years (01 year, extendable by 01 year). However, as per the options clause of GeM Portal, the tender tenure was extended by upto a maximum of 25% of the initial tender. Accordingly, considering that the total estimated financial implication is within the approval of GB for 02 years and that to ensure continuity in provision of Security Services, in anticipation of regularization in the Governing Body of SAI; the tender was floated for 02 years instead of 01 year extendable by 01 year.

The tender was floated on GeM Portal and a total of 86 Bids were received. The Technical Bid Evaluation Committee has evaluated the technical bids received and based on the terms and conditions of the RFP, the TBEC found that 02 bidders were technically responsive and recommended for the opening of the Price Bids of the 02 technically responsive bidders, i.e. M/s. Ironman Security Services Private Limited and M/s. SIS Limited.

With the approval of the TBEC Minutes, the price bids of the 02 technically responsive bidders were opened the price bid evaluation committee had noted that both the bidders had quoted same price i.e., Rs. 20,65,26,918.31 (at par with the estimated value of Rs. 20,65,26,638.03 for 02 years) and both the technically responsive bidders are L-1 bidders as per GeM. Further, as per GeM, bidders quoting same price are shown at same level, "Placement of contract by selection of any agency from amongst the L-1 bidders through an Algorithm run by GeM system." Subsequently, the committee opted for "Run L1 Selection" option in GeM Portal for finalizing the L1 bidder.

Accordingly, the option was chosen, and the GeM portal selected M/s S I S Limited @ Rs. 20,65,26,918.31 as L-1 bidder out of all technically responsive L-1 bidders, for Selection of Agency for Providing Security Services at 5 Stadia in New Delhi.

Further, as per Para 5.1 of the Delegation of Financial Powers of SAI, the financial powers delegated to DG-SAI is Rs. 05.00 Cr. in each case. Since the cost of said tender in the instant case is beyond the delegated financial powers of DG-SAI, the proposal was placed before Finance Committee for concurrence and before the Governing Body for approval.

Considering that the Security of the Stadia including the infrastructure and the athletes is of utmost importance and the urgency of the matter, concurrence of the Chairperson FC - Secretary Sports was obtained. Further, the approval of the Hon'ble Minister, MYAS - Chairman – Governing Body of SAI was obtained on file Dated: 19.11.24. Accordingly, the proposal is submitted for the Ratification of the Governing Body.

Approval of Governing Body is solicited for Ratification to award the contract to M/s SIS Limited for Selection of Agency for Providing Security Services at 5 stadia in Delhi @ ₹20,65,26,918.31 /- (Rupees Twenty crore Sixty-Five Lakh Twenty Six Thousand Nine Hundred Eighteen and Thirty One Paisa only) for a period of two years incl. of taxes.

Hiring of an Agency for providing Housekeeping Services at 05 Stadia of SAI in New Delhi

SAI looks after the management and operation of 5 Stadia in Delhi. The Housekeeping services have been deployed for the maintenance and upkeep of various common area, FOPs, washrooms etc. Presently, the services have been outsourced Stadia-wise. However, it has been felt that it would be prudent if centralized agency for all five stadia is to be engaged so as to achieve uniformity in timelines, economies of scale & to hire services of better rated agencies.

In view of that, an open tender was floated on GeM Portal, with the approval of the concurrence of the Finance Committee in its 122ndMeeting and the approval of the Governing Body in its 60thMeeting.

Accordingly, tender was floated for hiring of an Agency for providing Housekeeping Services at 05 Stadia in New Delhi for a period of 01 year, extendable by 01 year with a total estimated financial implication of Rs. 11,03,17,438/- for 02 years (01 year, extendable by 01 year). However, as per the options clause of GeM Portal, the tender tenure may be extended by upto a maximum of 25% of the initial tender. Accordingly, considering that the total estimated financial implication is within the approval of GB for 02 years and that to ensure continuity in provision of Housekeeping services, in anticipation of regularization in the Governing Body of SAI, as was followed in the case of Security Services, the tender was floated for 02 years instead of 01 year.

In response to the tender floated on GeM Portal, vide bid number GEM/2024/B/5619987, 19 bids were received. The Technical Bid Evaluation Committee had deliberated on the bids received and observed that 04 bidders, as detailed below were technically responsive and recommended for the opening of the financial bids of the 04 technically responsive bidders.

Further, with the approval of the Competent Authority, the Price Bid evaluation committee had evaluated the Price Bids of the 04 technically responsive bidders. The Price Bid Evaluation Committee had observed that out of 04 bidders, 01 bidder, i.e. M/s. SUN Facility Services Private Limited had not quoted as per the Minimum wages (as required in the RFP) and also not in the format specified in the ATC Document. Accordingly, the Price Bid of the

said bidder i.e. M/s. SUN Facility Services Private Limited was found non-responsive and the PBEC has evaluated the price bids of the 03 remaining financially responsive bidders. The rates quoted by them and the financial ranking are tabulated as below: -

Based on the above, the PBEC deliberated on the price bid of the L1 bidder and recommended for the approval of the competent authority to award the contract to M/s RAKSHAK SECURITAS PRIVATE LIMITED @ ₹11,76,65,255.90 incl. of taxes (Rupees Eleven Crore Seventy Six Lakh Sixty Five Thousand Two Hundred Fifty Five and Ninety Paise only) for Providing Mechanized Housekeeping services for 5 stadia in New Delhi, for a period of two years.

It is submitted that the financial implication in the subject procurement is Rs. 11,76,65,255.90/-. Further, as per Para 5.6 of the Delegation of Financial Powers of SAI, the financial powers delegated to DG-SAI is Rs. 05.00 Cr. in each case. Since the cost of said tender in the instant case is beyond the delegated financial powers of DG SAI, the proposal was placed before Finance Committee for concurrence and before the Governing Body for approval.

Considering that the Housekeeping of Stadia including the infrastructure is of utmost importance, and the urgency of the matter, concurrence of the Chairperson FC - Secretary Sports was obtained on file. Further, the approval of the Hon'ble Minister, MYAS - Chairman - Governing Body of SAI was obtained on file dated 31.12.24.

Accordingly, the proposal is submitted for the ratification of the Governing Body.

Approval of the Governing Body is solicited for Ratification to award the contract to M/s RAKSHAK SECURITAS PRIVATE LIMITED @ ₹11,76,65,255.90 incl. of taxes (Rupees Eleven Crore Seventy Six Lakh Sixty Five Thousand Two Hundred Fifty Five and Ninety Paisa only) for Providing Mechanized Housekeeping services for 5 stadia in New Delhi, for a period of two years.

The 2nd edition of Khelo India Para Games (KIPG) which were held in New Delhi from 20th to 27th March 2025, across three SAI Stadia in Delhi namely, Jawaharlal Nehru Stadium (JNS), Indira Gandhi Stadium (IGS) and Dr. Karni Singh Shooting Ranges (KSSR). The Games witnessed close to 1800 participants including approx. 1300 athletes.

3. In context of the above, it is mentioned that organising the Khelo India Games requires engagement of various agencies including the Event Management Agency (EMA) for Event Day Operation Overlays Sponsorship of Khelo India Para Games 2025. The EMA consists of experienced individuals from the hospitality industry with expertise in managing large scale Sports and Event Management sectors, having organised sports events at the international/national stage and the EMA often partners with various like-minded stakeholders to manage accommodation, catering & transportation of these events.
