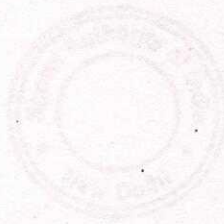

This Memorandum of Understanding (the 'MOU') is made and entered into this on 13<sup>th</sup> day of July-2015 at New Delhi.

BY AND BETWEEN

**School Sports Promotion Foundation (SSPF)**, having its office at 315/274, First Floor, Westend Marg, Mehrauli Badarpur Road, Said ul Ajab, New Delhi-110030 (including its successors and assignees) which is a sub-unit of the Gurukul Trust, a non-profit philanthropic trust, hereafter known as **First Party**.

AND

**Sports Authority of India(SAI)**, having its office at Jawaharlal Nehru Stadium Complex, East Gate, Lodhi Road, New Delhi-110003 (including its successors and assignees) a society registered under the Societies Act, 1860 by the Government of India with the objective of Promotion of Sports and Games, herein after known as **Second Party**.

Whereas Sports Authority of India is implementing number of Sports promotional schemes in the country viz, SAI Training Centre, Special Area Games, National Sports Talent Context, Army Boys Sports Companies, Centre of Excellence and National Sports Academies.

Whereas both the parties share the common objectives and goals for promoting and developing sports and sportspersons, therefore, resolve to work together on the following terms:

- SSPF will conduct tournaments for scouting talent and organize coaching camps for nurturing the talent in sports and games.
- SSPF will be supported by Sports council headed by eminent sports persons and proven managers. The Council shall be responsible on behalf of the SSPF for conduct of tournaments in the existing sports infrastructure in schools across the country.
- Any other activity on mutually agreed basis.

And whereas second party (SAI) which is having expertise in coaching and technical support shall provide necessary technical support and guidance wherever necessary subject to availability of experts in different sports specific disciplines, and further, depending upon availability and allow access and usage of SAI centres for sports related activity to SSPF provided it does not dislocate or inconvenience implementation of SAI's own schemes.

For better coordination SSPF may induct a member to be nominated by Sports Authority of India on the Executive Committee of SSPF.

The MOU will be on voluntary basis and either party can withdraw from it without any obligation if it so desires by giving a notice of 1 month.

This MOU is initially for a period of 3 years and may be renewed by mutual consent on same or revised terms as may be settled between the two parties.
