CIRCULAR

Sub:- Revision of Travelling Norms under Competition Exposure Head for athletes from North East Region (NER), Lakshadweep and Andaman & Nicobar islands-reg.

It has been observed that major sports competitions are generally organized in the mainland. The STC athletes from NER and Union Territories of Lakshadweep and Andaman & Nicobar Islands cannot avail of train facility and a lot of time is wasted on travel by Road/Ship. They also find it difficult to manage their travel by air.


The Governing Body of SAI in its 60th meeting held on 08th August, 2024 has approved the revision of travelling expenditure norms for athletes of STCs located in far flung regions i.e. NER, Lakshadweep and Andaman & Nicobar islands under 'Competition Exposure Head' w.e.f. FY 2024-25 as below:-

S. N	Head of Expenditure	Region	Existing expenditure norms per athlete (in Rs.)	Revised expenditure norms per athlete (in Rs.)*
1.	Competition Exposure	North East Region	3,000/-	8,000/-
		Island Territories	3,000/-	20,000/-

*This will be subject to a maximum of 02 competition exposures with ceiling of Rs. 10,000/- per athlete per exposure for Lakshadweep and Andaman & Nicobar Islands and Rs. 4,000/- per athlete per exposure for North East Region under SAI Block Grant w.e.f. FY 2024-25.

The athletes may be allowed to travel by any mode of transport i.e. air/train/ship within the ceiling.
