iii. 45% - 50%	- 10 marks
iv. Less than 45%.	- 0 marks
ii. Weightage work experience (35 Marks) with further break-up as:	
i. Greater than 07 years	- 35 marks
ii. 06-07 years	- 25 marks
iii. 05-06 years	- 15 marks
iii. Weightage for work Experience in Sports Sector (25 marks) with further break-up as:	
i. Greater than 05 years	- 25 marks
ii. 04-05 years	- 15 marks
iii. 03-04years	- 05 marks
iv. Weightage work experience in any government/ Semi Govt. / Autonomous / PSU in a relevant field as mentioned in JD (10 Marks) with further break-up as:	
i. Greater than 02 years	- 10 marks
ii. 01-02 years	- 05 marks
Note: If a candidate is working in Sports Sector and (or) in the government sector as specified in iv, he/she will be eligible for weightage in ii, iii & iv depending on the number of Years of Experience
