Norms for hiring of General Physician / Doctor Grade-II on contractual under Khelo India Scheme at Khelo India State Centre of Excellence, Agartala

ELIGIBILITY CRITERIA AND TERMS & CONDITIONS:

1. Qualifications:

Essential: MBBS Degree from any recognized Indian or Foreign University and should compulsorily be recognized by Medical Council of India. Masters in Sports / Diploma in Sports / Fellowship in Sports will be preferred.

Experience: Minimum 1 (one) year of research / experience with the National / State Athletes.

2. Age Limit: The candidate must not have attained **45 years** of age as on the closing date of advertisement.

3. Remuneration: Monthly remuneration of ₹ **60,000 – 80,000**.

4. Criteria for shortlisting of candidates who fulfill the essential qualification for interview:

Categories for evaluation	Max. marks	Scoring of Marks
Work experience over and above essential work experience	10	2 marks will be awarded for every completed 1 year of work experience in relevant field up to a maximum of 10 marks
Work experience in sports establishment	10	Additional 2 marks will be awarded for every completed 1 year of work experience in relevant field at State / National level organization (Govt. or Private) up to a maximum of 10 marks.

5. The shortlisted candidates will be called for the Interview and assessed as follows:

6. Job Responsibilities:

- a. Shall conduct annual medical examination of all comes at the beginning of State / National Coaching camp and communicate results.
- b. Shall be attending all day to day injuries of athletes and staff of the concerned Centre.
- c. To conduct counseling with the athlete who are deficient in biochemical markers and evolve a suitable plan to correct the deficiency if any.
- d. Shall be head for medical team and would work closely with the team physiotherapist and masseur for injury management, return to play and rehabilitation.
- e. Contribute in applied research.
- f. Publication in SCI indexed peer reviewed journals published in the state as well in India or abroad.
- g. Any other duties assigned by the High Performance Director, Sports Science Head, Tripura Sports School Head, Regional Head (SAI) and Director (YAS, Govt. of Tripura).

GENERAL CONDITIONS:

1. **Tenure:** The contractual engagement will be for a period of one year, it may further increase up to three (3) years on the basis of satisfactory performance, periodic reviews, result oriented, etc. and at all times coterminous with the Khelo India Scheme.
2. **MOU:** Selected candidates shall be required to sign a contract agreement as per terms and conditions of Khelo India. The contract shall end on expiry of the prescribed period and no separate notice shall be required to be given.
3. **Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the State Sports Department will issue TDS /Service Tax Certificates, as applicable.
4. **Other Allowances:** No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.
5. **Extension:** Performance of the selected candidates would be continuously reviewed and extension will be considered on the basis of periodic review / requirement.
6. **Leave:** Selected candidates will be entitled for 30 days leave in a calendar year on pro-rata basis. Thereafter, candidates shall not draw any remuneration in case of his/her absence beyond 30 days in a year. Also unveiled leave in a calendar year will lapse and will not be carried forward to the next calendar year.

- 7. Age:** The date of birth, accepted by the Youth Affairs & Sports Department, Tripura is that entered in the Matriculation or Secondary School Leaving Certificate or in a certificate recognized by an Indian University as equivalent to Matriculation or in an extract from a Register of Matriculates maintained by a University which extract must be certified by the proper authority of the University or in the Higher Secondary or an equivalent examination certificate. Aadhaar Card/Passport/Voter Id will also be accepted. No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service records and the like will be accepted. The expression Matriculation / Higher Secondary Examination Certificate in this part of the Instruction include the alternative certificates mentioned above.

8. CONFIDENTIALITY

- a) Selected persons will not be allowed to publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymously in the name of any other person, if such book, article, broadcast, uses any information that the/she may gather as part of this assignment.
- b) During the period of engagement with Youth Affairs & Sports Department, Tripura, Employee would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by him/her during the period of his/her engagement to anyone who is not authorized to know.
- c) The Selected personnel at no instance can represent or give opinion or advice to others in any matter, which is adverse to the interest of the Government.

9. OTHER CONDITIONS

- a) The applications received will be scrutinized / shortlisted on the basis of relevant experience and job description and the eligible candidates will be called for Interview at cost to the applicant.
- b) Candidates applied for more than one post will be interviewed only once.
- c) In case he/she is required to proceed outstation from the place of posting on tour for official duty, he/she will be entitled to TA/DA as admissible under the rules.
- d) In case the performance of Candidate is not found satisfactory, his/her services will be discontinued after giving one month notice.

- e) Without any prejudice to the above condition, the candidate will be terminated from his/her services with immediate effect without any obligations, in case the candidate is found guilty of violating any of the conditions contained in the terms of employment or is guilty of any misconduct including negligence of duties, unauthorized absence, etc.
- f) Decision of Youth Affairs & Sports Department, Tripura in all matters regarding eligibility, selection and posting would be final and binding upon all candidates. No representation or correspondence will be entertained by STATE SPORTS DEPARTMENT in this regard.

- h) The DGSAI shall be the final authority in case of any dispute.
- i) The appointment will be purely on contract basis and does not confer any right to claim to permanent employment in STATE SPORTS DEPARTMENT.
- j) Any litigation matters pertaining to employment at STATE SPORTS DEPARTMENT shall be restricted to the jurisdiction of the Agartala courts.
- k) Organization (DYAS) reserves the right to terminate the contract, by giving one month notice to Candidates.
