4. Candidates will be called for the interview on the criteria mentioned above. Hence, the fulfillment of eligibility criteria does not entail that candidate will be considered for the interview.

If, on verification at any stage, before or after the Interview, it is found that they do not fulfill any of the eligibility conditions; their candidature will be canceled by SAI.
