IV SELECTION PROCESS:

- i) Last date for receipt of application will be 13.02.2026
- ii) Application received up to a prescribed date will be scrutinized by the ZSPC-W Food Corporation of India, Selected candidates will be called for verification of original documents. However, the corporation reserves the right to conduct any Trial or Test as it may deem fit, depending upon the number of applications received and circumstances.
- iii) Only the one best certificate of last three years shall be considered for marking the candidate. In case of more number of applicant candidate than the required number with equal marks as per table given below, then the second-best certificate of the candidates shall be benchmarked for selection and so on till the number of selected candidates matches the requirement.
