PRE QUALIFICATION CRITERIA

TECHNICAL CRITERIA

The bidder should have successfully completed similar works during the last 5 years ending previous day of last date of submission of tenders:

One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

Three similar completed works, each costing not less than the amount equal to 40% of the estimated cost put to tender.

The Term similar nature of work & Other Infra structure Work.

FINANCIAL CRITERIA

Average Annual Financial turnover on construction works should be at least 50% of the estimated cost put to tender during the immediate last three consecutive financial years.

The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet, duly audited and certified by Chartered Accountant.

MODE OF SUBMISSION OF TENDER

Item rates Tender under Two Bid Systems containing two covers of technical bid and financial/price bid should be submitted online. Conditional tender shall not be accepted.

OPENING OF FINANCIAL BIDS/PRICE BID

1. Exact date and time shall be communicated through official E- mail address given in the bid document to the qualified bidders.
2. Conditional bids would be summarily rejected.
3. In case no bid or single bid is received, or any other reason whatsoever, SAI may at its sole discretion to cancel the whole tendering process or extend the last date and time of submission of the bid.
4. Any separately submitted discount letter on the financial price shall not be considered by SAI and shall be a ground for disqualification. Evaluation of financial bid shall be considered only on the quoted price in the financial bid submitted by the bidders.

INSTRUCTIONS FOR ONLINE BID SUBMISSION:

This tender document has been published on the Central Public Procurement Portal (URL: <http://eprocure.gov.in>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. More information useful for submitting online bids on the CPP Portal may be obtained at: <https://eprocure.gov.in/eprocure/app>.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link “Click **here to Enroll**” on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g.Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

General information for the Vendors/Agencies for their prequalification to carry out the above-mentioned works on turnkey basis

1. The contractor should quote in the Rate and Amount column of the given price bid document only. However, if a discrepancy is found, the rate which correspond with the amount worked out by the contractor shall unless otherwise proved, be taken as correct. If the amount of an item is not worked out by the contractor or it does not correspond with the rate written either in figure or in words then the rate quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and in words tally but the amount is not worked out correctly, the rate quoted by the contractor will be taken as correct and not the amount.
2. Contractor must ensure to quote rate of each item. If no rate is quoted by the bidder, rate of such item shall **be treated as "0" (ZERO)**.
3. Eligible firm coating the lowest price will be selected.
4. Intending contractors / vendors are requested to read carefully before filling the particulars in the Performa.
5. Information / details furnished by selected party, if found to be false / incomplete at any time in future or any information effecting prequalification is willingly / unwillingly withheld, if come to the notice of the SAI at any point of time, the company's prequalification will be cancelled immediately.
6. Where copies are required to be furnished, these should be self-certified copies.
7. The cutoff date for calculation of past period for completion of projects shall be last date of submission of bid.

8. All pages of the tender document i.e. Pre-qualification criteria, Technical bid, Price Bid should be signed and stamped by bidder.
9. Contractor shall appoint a Full time Graduate Engineer having minimum 2 Years Experience or a Diploma Engineer having minimum 5 Years Experience for monitoring the day-to-day progress of work of site at their own cost.
10. As per CPWD approved make only allowed and as per the direction of competent authority.
11. **All the terms and conditions followed by the CPWD norms and General Conditions of contract.**

Additional Terms and Conditions

1. Every AC unit shall be serviced once every three months.
2. Breakdown calls should be attended on that day itself. In the event of breakdown calls remaining unattended for more than 24 hours, a recovery of Rs.500/- or part thereof shall be made.
3. Replacement of defective spare parts like capacitors, start relay, wiring materials etc. will be the responsibility of the contractor without any extra cost. The damaged items replaced shall have to be handed over to the officer in charge.
4. Transportation of Air-Conditioner Units from the LNCPE to the service provider's workshop, from one building to another and from the service provider's workshop to the LNCPE, will be at the cost of the service provider
5. A log book shall be maintained for the servicing and repairs carried out and got signed by the officer in charge of the work from time to time.
6. The bidder shall be deemed to have inspected the site and understood the scope of work prior to quoting rates.
7. The payment to the contractor shall be made through PFMS/RTGS/NEFT only, after successful completion of the work and upon verification by the Committee.
8. No advance payment shall be made. Quarterly payments will be released within 20 days of the submission of the bill/invoice, subject to satisfactory performance and certification by the Committee.
9. The item mentioned in Price Bid Part B is tentative and shall be executed as per the actual requirements during the AMC period.
10. Payment of items reflected in Price Bid Part B will be made as per actuals.
11. The successful bidder shall submit the relevant invoice(s) and warranty card(s) for all defective parts replaced, such as the compressor, fan motor, condenser, PCB, and any other associated components.

12. Only Original Equipment Manufacturer (OEM) spare parts shall be used for the equipment and components.
13. The total cost quoted by the L1 bidder under Part-A (AMC charges) shall be divided into four equal quarterly installments. Payment for each quarter shall be released only after the successful completion of the respective quarter's AMC services and upon submission of the corresponding bill,
14. The contractor shall not sub-contract any part of the work during the AMC period. The contractor shall be wholly and solely responsible for the execution, quality, and performance of the services under all circumstances.
15. During preventive maintenance, the air conditioners shall be serviced once every quarter (i.e., every 3 months). This shall include thorough cleaning of the indoor unit air filters and complete cleaning of the outdoor units using a blower or water wash, along with all other necessary servicing to ensure proper functioning.
16. The Service Engineer shall bring all necessary tools and instruments required for servicing, including but not limited to vacuum cleaner/blower and ladders required for cleaning and maintenance of the air conditioning units.
17. All spares (Part-B) required during the periodical maintenance of the air conditioners shall be replaced for a period of one year, strictly as per the list of spares specified in the tender. No exceptions shall be entertained in this regard. The finalized rates quoted under Part-B shall be applicable and binding for the entire one-year period.
18. The bidder should have a functional local office within a radius of 100 km from the SAI LNCPE campus and must possess a valid GST registration (GST No.) for the same.
