GENERAL INFORMATION AND INSTRUCTIONS TO BIDDERS

[GFR Rule 161 & 173] This is an Advertised Tender Enquiry published at IKCA Website www.ikca.in and SAI Website (www.sportsauthorityofindia.nic.in) as the estimated value exceeds Rs. 25 Lakhs, in compliance with GFR Rules 159, 160 and 161.

1. INTRODUCTION

The Indian Kayaking & Canoeing Association (IKCA), an autonomous body affiliated to the Sports Authority of India (SAI), Ministry of Youth Affairs & Sports, Government of India, invites sealed bids through Two Bid System (Technical Bid & Financial Bid) from eligible, reputed and experienced suppliers/firms for **Supply of ICF & IKCA Approved Canoe / Kayak Slalom Boats, Extreme Slalom Boats & Accessories.**

The tender is being issued in compliance with the General Financial Rules (GFR), 2017 issued by the Ministry of Finance, Department of Expenditure, Government of India, as amended from time to time up to date.

2. GEM AVAILABILITY CERTIFICATE

[GFR Rule 149] It is hereby certified by the competent authority that the Kayaking and Canoeing Equipments as specified in Annexure-A of this RFP are specialized sports equipments that require ICF (International Canoe Federation) and IKCA approval. These items have been examined on Government e-Marketplace (GeM) portal and are either not available or not available from ICF & IKCA approved brands in the required specifications and quantities. Therefore, procurement is being made through Advertised Tender Enquiry as per GFR Rule 161.

If any item is found available on GeM in future during the procurement process, the same shall be procured through GeM mandatorily.

5. Affidavit / Undertaking as per Annexure-E (Non-Debarment & Price Declaration).
6. Clause-by-Clause Compliance Statement of Technical Specifications as per format in Part II, Para 3.
7. Past Performance Statement: Copy of Supply Orders for kayaking/canoeing items from Central Govt./State Govt./NSF/PSU/SAI for last 3 years. Any one order value \geq Rs. 1.00 Crore.
8. CA-certified Turnover Statements for FY 2022-23, 2023-24, 2024-25 (Average Annual Turnover \geq Rs. 2.00 Crore).
9. Self-attested copies of PAN Card and GST Registration Certificate.
10. MSME/Udyam Registration Certificate/Startups Certificates.
11. Make in India Declaration as per Annexure-H.
12. Product Brochures for all quoted items.
13. Undertaking that all items quoted as per Annexure-A.
14. Code of Integrity Declaration as per GFR Rule 175 (included in Annexure-E).

7.2 FINANCIAL BID (Price Bid)

- (a) Financial Bid to be submitted ONLY in the format of Appendix-I and should be submitted / sent via email ikcasports@gmail.com duly Password Protected PDF file before the due date of submission i.e 10th March 2026 @ 05:00 pm.
- (b) Prices should be quoted INCLUSIVE of GST and other charges, levies, packing, forwarding, insurance, freight and delivery charges to Consignee at consignee. However, GST should be mentioned separately in price bid as per format.
- (c) Custom Duty Exemption Certificate will be provided by IKCA/SAI for imported goods, if required.

8. EARNEST MONEY DEPOSIT (BID SECURITY)

[GFR Rule 170(iii)] In lieu of Earnest Money Deposit (EMD), Bidders are required to submit a BID SECURITY DECLARATION as per Annexure-B in accordance with GFR Rule 170(iii). No monetary EMD/Bid Security is required.

Key provisions:

- i. The Bid Security Declaration shall remain valid till the final bid validity period.
- ii. Breach of any bid condition during validity period shall result in disqualification and debarment from IKCA tenders for a period of one year.

9. VALIDITY OF BIDS

[GFR Rule 174(iii)] Bids shall remain valid for a period of 90 (Ninety) days from the date of opening of Technical Bids. IKCA reserves the right to request extension of bid validity in exceptional circumstances, and bidders may agree or withdraw their bids without forfeiture.

10. REJECTION OF BIDS

Bids shall be rejected in the following circumstances (GFR Rule 173):

- a) Bids not submitted through CPPP e-procurement portal.
- b) Bids received after the deadline for submission (Late Bids — GFR Rule 165).
- c) Bids not fulfilling Pre-Qualification Criteria.
- d) Conditional bids or bids with deviations from essential technical specifications.
- e) Bids with NIL charges/consideration.
- f) Canvassing, unsolicited letters, or post-bid corrections by the Bidder.
- g) Bids where the bidder has been debarred under GFR Rule 151.
- h) Bids with incomplete documents or forms not as per prescribed formats.
- i) Bids not covering all items in Annexure-A.

11. UNWILLINGNESS TO QUOTE

Bidders who are unable to submit bids must communicate their unwillingness to IKCA before the closing date. Failure to do so may result in delisting from IKCA's registered vendor list for the concerned category of goods.

12. MODIFICATION AND WITHDRAWAL OF BIDS

[GFR Rule 173(iii)] No modification or withdrawal shall be permitted after the deadline. Bids shall not be altered post deadline.

13. OPENING OF BIDS

[GFR Rule 173(viii)] Technical Bids shall be opened on the date and time specified in the Critical Date Sheet. Financial Bids of only technically qualified bidders shall be opened subsequently, and date shall be communicated separately.

14. MAKE IN INDIA PREFERENCE

[GFR Rule 153(iii) & MoF OM] Purchase preference shall be given to domestically manufactured goods or locally provided services as per the Public Procurement (Preference to Make in India) Order 2017 and subsequent amendments by DPIIT, Ministry of Commerce & Industry. Bidders offering domestically manufactured goods must submit Annexure-H.

2. TECHNICAL INFORMATION REQUIREMENTS

[GFR Rule 168 Ch-4] The technical bid must contain complete technical information to facilitate full technical scrutiny. The vendor must volunteer all information required. IKCA reserves the right to seek necessary technical clarifications. No commercial change shall arise from technical clarifications.

A copy of the product brochure (with technical specifications, ICF and IKCA approval certificates) shall be submitted along with the Technical Bid.

3. CLAUSE-BY-CLAUSE TECHNICAL COMPLIANCE FORMAT

[GFR Rule 163] As per Two-Bid System requirements, Bidders MUST furnish clause-by-clause compliance of specifications clearly indicating any deviations. Submit in the following format:

4. DELIVERY PERIOD

- a. **Delivery Period: Within 120 (One Hundred Twenty) days from the date of issue of Supply/Purchase Order.**
- b. **Part-Shipment/Part-Delivery: Permitted. Full quantity must be supplied within the stipulated delivery period.**
- c. Extension of Delivery Period: Extension, if required, may be granted at the sole discretion of IKCA/Buyer, subject to applicability of Liquidated Damages (LD) clause as per Part III (6).
- d. Time is the essence of the contract. Any undue delay shall attract LD provisions.

5. CONSIGNEE DETAILS

6. INSPECTION AND QUALITY

[GFR Rules 144, 169, 171]

- a) **Pre-Dispatch Inspection:** The Buyer/IKCA reserves the right to inspect and test the goods before dispatch. The Seller shall provide all necessary facilities.
- b) **Joint Receipt Inspection (JRI):** All goods shall be inspected jointly by a committee comprising representatives constituted by IKCA upon delivery at consignee location. Acceptance of goods shall be subject to satisfactory JRI.
- c) Goods found defective or not conforming to specifications during JRI shall be rejected and returned to the Supplier at Supplier's cost. Supplier must replace/rectify within **45 days**.
- d) **ICF and IKCA Certification:** Each item supplied must carry valid ICF and IKCA approval certificate/marking at the time of delivery.
- e) The Buyer may engage a third-party testing agency if required, cost to be borne by Buyer.

PART – III

STANDARD CONDITIONS OF RFP / CONTRACT

The Bidder is required to give confirmation of acceptance of all Standard Conditions mentioned below. These conditions shall automatically form part of the Contract concluded with the successful Bidder. Failure to accept may result in rejection of the Bid.

1. GOVERNING LAW

The Contract shall be governed by and interpreted in accordance with the Laws of the Republic of India. Any dispute arising out of or in connection with this Contract shall be subject to the jurisdiction of the competent courts/tribunals at New Delhi.

2. EFFECTIVE DATE OF CONTRACT

The Contract/Supply Order shall come into effect on the date of signatures of both parties on the contract (Effective Date) and shall remain valid until completion of all obligations including warranty obligations. Delivery and supplies shall commence from the Effective Date of Contract.

3. DISPUTE RESOLUTION AND ARBITRATION

[GFR Rule 173(v)]

- (a) All disputes or differences arising out of or in connection with the Contract shall first be settled through bilateral discussion/negotiation between the parties.
- (b) If disputes cannot be settled amicably within 30 days, the matter shall be referred to Arbitration under the Arbitration and Conciliation Act, 1996 (as amended) and any rules made thereunder.
- (c) The seat and venue of Arbitration shall be New Delhi. The language of Arbitration shall be English/Hindi.
- (d) The decision of the Arbitral Tribunal shall be final and binding on both parties.

4. CODE OF INTEGRITY AND ANTI-CORRUPTION

[GFR Rule 175] No official of IKCA/SAI or the Bidder shall act in violation of the Code of Integrity. The following are strictly prohibited:

- a) Making, offering or accepting any bribe, reward, gift, commission, fee or inducement to any person in Government service.
- b) Any omission or misrepresentation to obtain financial benefit or avoid obligation.
- c) Collusion, bid-rigging or anti-competitive behaviour that impairs transparency or fairness.
- d) Improper use of information provided by the procuring entity for unfair advantage.
- e) Any financial/business transaction between the Bidder and IKCA/SAI officials that can affect procurement decisions.
- f) Coercion or threats to influence the procurement process.
- g) Obstruction of any investigation or audit of procurement
- h) Providing false declarations or information in the tender process.

CONSEQUENCES: Violation of the Code of Integrity shall result in

- (i) disqualification/debarment from IKCA tenders (GFR Rule 151);
- (ii) termination of Contract;
- (iii) forfeiture of Performance Security;
- (iv) recovery of losses;
- (v) reporting to DGS&D/CBI/CVC as appropriate.

5. NON-DISCLOSURE OF CONTRACT DOCUMENTS

Except with the written consent of the Buyer/Seller, neither party shall disclose the Contract, any provision thereof, or any specification, plan, design, pattern, sample or information thereof to any third party. This obligation shall survive the termination of the Contract.

6. LIQUIDATED DAMAGES (LD)

[GFR Rule 173]

- (a) In the event of the Seller's failure to supply the items within the stipulated delivery period, Liquidated Damages shall be levied at the rate of 0.5% (half percent) of the contract price of the delayed/undelivered stores per week of delay or part thereof.
- (b) The maximum LD shall not exceed 10% of the total contract value of the delayed stores.
- (c) LD shall be deducted from the bills/invoices of the Seller or from the Performance Security.
- (d) Levy of LD does not relieve the Seller from obligation to complete the supply.
- (e) In case of Force Majeure, LD may be waived with approval of competent authority and proper documentation.

7. TERMINATION OF CONTRACT

The Buyer shall have the right to terminate this Contract in the following cases:

- (a) Delivery of material is delayed by more than 06 (six) months beyond the scheduled delivery date for causes NOT attributable to Force Majeure.
- (b) The Seller is declared bankrupt or becomes insolvent.
- (c) Delivery is delayed due to Force Majeure for more than 06 months.
- (d) The Buyer discovers that the Seller has used any agent and paid commission in procuring this contract, in violation of GFR provisions.
- (e) Breach of Code of Integrity (GFR Rule 175).
- (f) As per decision of the Arbitration Tribunal.
- (g) In case of termination, Buyer reserves the right to procure from alternate sources at Seller's risk & cost (Risk Purchase Clause).

8. TAXES, DUTIES AND LEVIES

A. GST / IGST / SGST / CGST:

- a. Prices should be quoted INCLUSIVE of GST and other charges, levies, packing, forwarding, insurance, freight and delivery charges to consignee location.
- b. If GST is quoted separately, the applicable rate and nature must be specified. GST shall be paid at the rate applicable and legally assessed at the time of supply.
- c. Any reduction in total cost due to change in tax structure or input tax credit shall be passed on to the Buyer.

B. CUSTOMS DUTY:

Custom Duty Exemption Certificate will be provided by IKCA/SAI/Government to the Seller for imported goods as and when required.

- C. **OTHER LEVIES:** All other levies, duties surcharges, cess, packing, freight, insurance and delivery charges are inclusive in the quoted price.

9. PAYMENT TERMS

[GFR Rule 172] Advance Payment

- (a) 25% Advance Payment: May be released upon receipt of confirmed Supply Order as per Terms and Conditions/Advance Payment Declaration as per Annexure-G.
- (b) 50% Payment: Released on pro-rata basis upon presentation of:
 - (i) Bidder's invoice/proforma invoice, (ii) Bill of Lading/Lorry Receipt/AWB, (iii) Packing List, (iv) ICF/IKCA Certificate for supplied goods. (v) Pre-Dispatch factory Inspection report from the OEM.

- (c) Balance 25% Payment: Released after Joint Receipt Inspection (JRI) and final acceptance of goods at consignee location upon submission of:
- (i) Supplier's tax invoice,
 - (ii) Packing List,
 - (iii) Delivery Challan,
 - (iv) Guarantee/Warranty Certificate,
 - (v) Bank Mandate Form (ECS/PFMS).
- (d) ALL PAYMENTS shall be made through PFMS (Public Financial Management System) / ECS / EFT/RTGS/NEFT. Bidders must furnish bank account details.

10. PERFORMANCE SECURITY

[GFR Rule 171]

- a) The successful Bidder shall furnish Performance Security for 3% (three percent) of the contract value within 30 (thirty) days of receipt of the confirmed Supply Order/Contract.
- b) Performance Security shall be in the form of: Account Payee Demand Draft / Fixed Deposit Receipt / Bank Guarantee from a scheduled commercial bank / Online payment in PFMS
- c) Performance Security shall remain valid for a period of 60 (sixty) days beyond the date of completion of contract/work order/supply order.
- d) Bid Security Declaration shall be returned/discharged on receipt of Performance Security.
- e) Performance Security shall be forfeited in case of breach of contract terms by the Seller.

PART - IV
SPECIAL CONDITIONS OF RFP

The Bidder is required to give confirmation of acceptance of all Special Conditions mentioned below which shall automatically form part of the Contract.

1. FALL CLAUSE

- a. The price charged for stores supplied under the contract shall in no event exceed the lowest price at which the Seller sells or offers to sell the stores of identical description to any person/organization including the Buyer, any Department of Central Government, State Government or Statutory Undertaking during the period of contract.
- b. If the Seller reduces the sale price or offers at a lower price to any entity during the contract period, the Seller shall forthwith notify IKCA/Buyer and the contract price shall stand correspondingly reduced.
- c. Exceptions: Exports by the Seller; sale of goods with expiry dates; sale at lower price on/after completion of previous contracts.

2. RISK AND EXPENSE CLAUSE

- a. If stores are not delivered within the stipulated time, or defective delivery is made, the Buyer shall, after granting the Seller 45 days to cure the breach, be at liberty to declare the Contract cancelled (wholly or partially) without prejudice to LD recovery.
- b. If stores do not conform to specifications during inspection/testing, the Buyer may cancel the Contract wholly or partially without prejudice to other remedies.
- c. On material breach not remedied within 45 days, Buyer shall have right of first refusal to Seller and may then procure from alternate sources at Seller's risk and cost.
- d. Excess cost of risk purchase shall be recoverable from the Seller, not exceeding 10% of the contract value.

3. FORCE MAJEURE CLAUSE

- a. Neither party shall bear responsibility for failure to perform obligations due to Force Majeure circumstances — including Flood, Fire, Earthquake, Acts of God, War, Military Operations, Blockade, Government Actions, or other circumstances beyond the parties' control — arising after conclusion of the contract.
- b. Time stipulated for performance shall be extended correspondingly for the period of Force Majeure and its consequences.
- c. The party unable to meet obligations must notify the other party in writing within 10 days of commencement of Force Majeure.
- d. If Force Majeure continues for more than 6 months, either party may terminate the Contract with 30 days' prior written notice, without liability other than reimbursement for goods received.

4. WARRANTY CLAUSE
